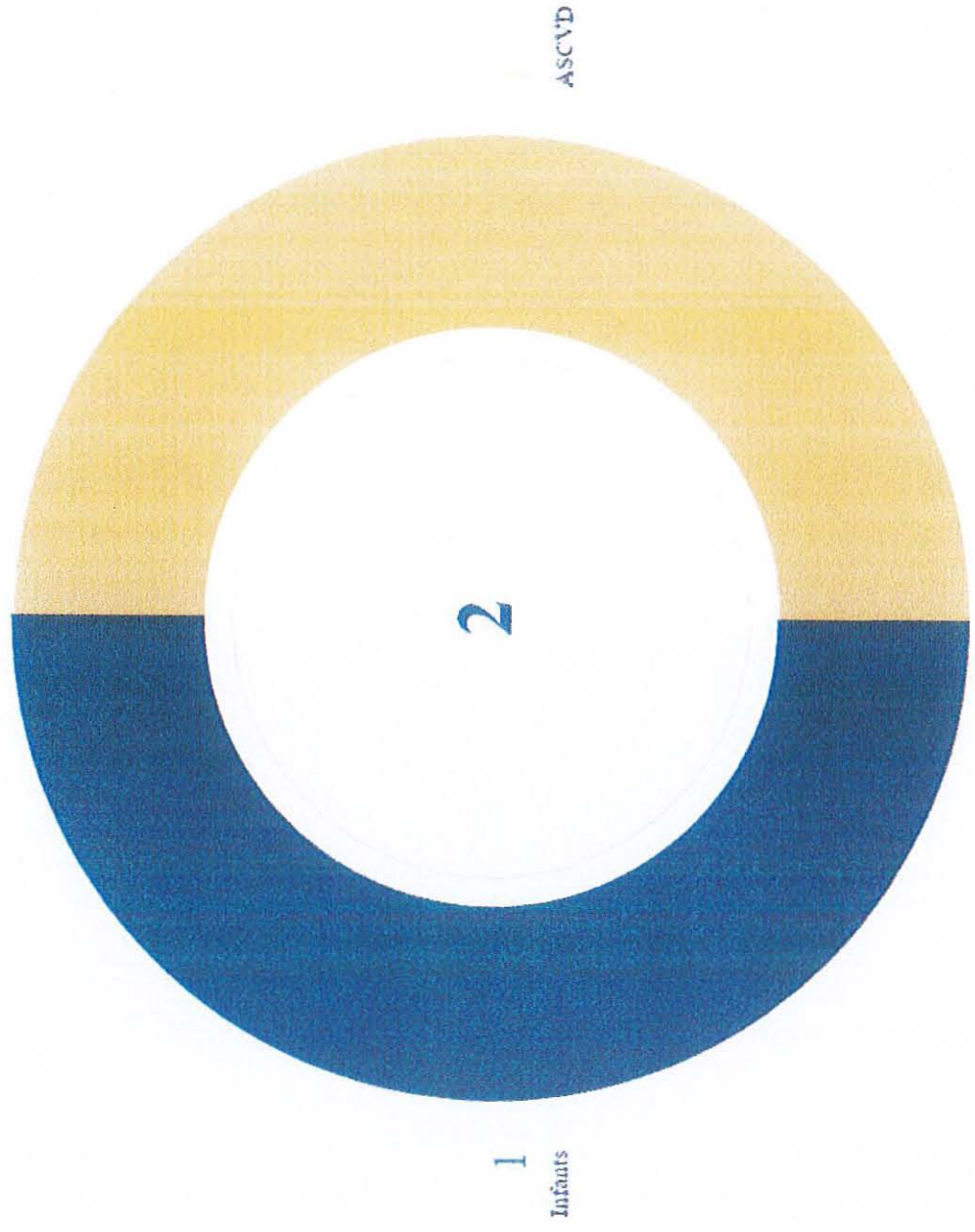
Pleasants County - 2021 Wood County Coroner (Incident)



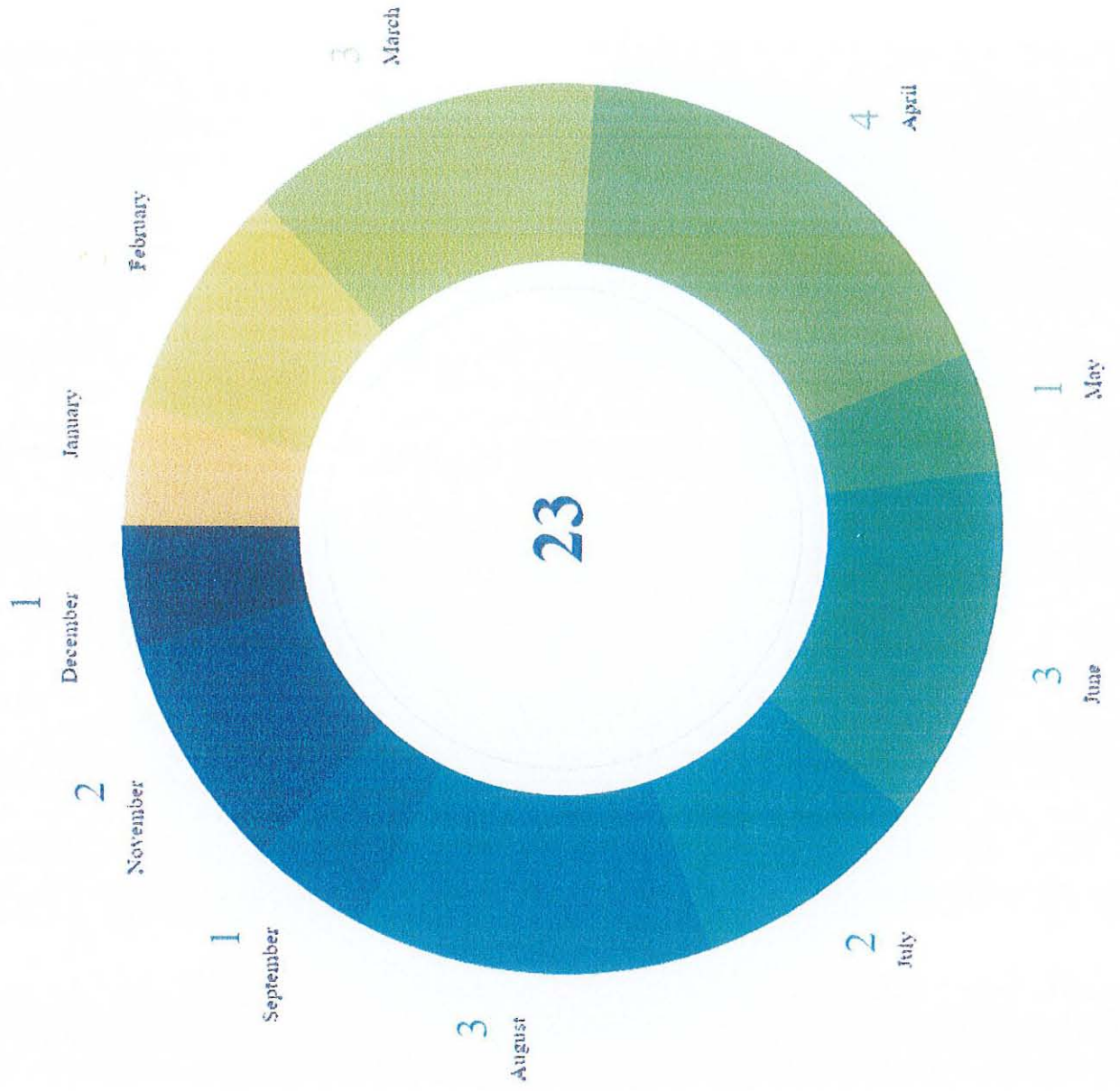
