Dear Marty:

It was a pleasure to speak to you last week. Lewis Glasser PLLC (the "Firm" or "Lewis Glasser") proposes the following representation based upon the terms and conditions as outlined below:

- 1. Client: Our Client will be the Wood County Commission ("Client").
- 2. Scope of Work: The Firm will provide representation to the Client regarding matters related to the recently enacted American Rescue Plan Act of 2021 and the associated regulations ("Act"). We will assist the Client in navigating the requirements of utilizing any funds in the investment of projects received by virtue of the Act, and any related prohibitions or limitations provided in the Act.
- 3. **Delegation of Work:** Where appropriate, certain work on legal matters may be performed by attorneys or legal assistants at Lewis Glasser other than the attorney primarily responsible for this matter. Should you have any questions or concerns about attorneys or legal assistants working on your matter, please contact us immediately.
- 4. **Method of Determining Legal Fees:** Our fees for legal services will be based on the time Lewis Glasser expends on your behalf, recorded and billed usually in increments of 15 minutes. Our fees for this matter are \$300 per hour for partners, \$200 per hour for associates, and \$100 per hour for paralegals. Upon engagement, Lewis Glasser cannot estimate total legal fees associated with your matters because the actual amount of legal fees will depend upon the time expended on each matter.
- 5. Out-of-Pocket Costs: Lewis Glasser might incur certain out-of-pocket expenses in providing services in connection with this matter, including but not necessarily limited to costs for photocopy services, messenger or courier services, computerized research, conference telephone calls, travel and other similar costs. As a part of our

engagement, you will reimburse Lewis Glasser for out-of-pocket costs incurred in connection with this file. If there are unusual costs that we believe need to be incurred in connection with this matter, we will discuss these costs with you before they arise.

- 6. **Billing and Payment:** Invoices for legal services and costs will be issued monthly and will contain detail related to our services and the time expended on this matter. Invoices will include the total amount of legal fees and total amount of out-of-pocket costs as of the date of the invoice. Invoices are payable upon receipt.
- 7. Withdrawal: You may terminate our representation in this matter at any time upon written notice. Likewise, Lewis Glasser reserves the right to withdraw from this matter, following the delivery of written notice, for any reason permitted under the West Virginia Code of Professional Responsibility. If an invoice is not paid when due, Lewis Glasser may withdraw from this matter. In the event of the termination of Lewis Glasser's legal representation for any reason by either Lewis Glasser or you, you agree to pay such fees and legal costs incurred up to the date of notice and, upon payment, Lewis Glasser will cooperate to transfer your matter to any successor legal counsel that you might retain.

### 8. File Storage and Retention:

- (A) Except in the event of a *force majeure* event, or other circumstances beyond Lewis Glasser's control, Lewis Glasser will retain our file related to this matter, at the conclusion of our representation, for not more than 60 months. During that time, our file, less our work product, will be available to you upon written request.
- (B) The file that we possess will be retained electronically on systems maintained by Lewis Glasser or by a third-party technology management contractor. Unless specifically limited by separate agreement, Lewis Glasser's employees and staff may have access to our files. Lewis Glasser has taken measures to protect its electronic systems from unauthorized access and inadvertent loss, consistent with the requirements of the West Virginia Code of Professional Responsibility; *however*, Lewis Glasser makes no guaranties or representations regarding safety or security of its files.

### 9. Confidentiality and Privilege; use of Client Information:

(A) Lewis Glasser will not reveal confidential or privileged information relating to our representation unless (i) you give informed consent to the release of such information; (ii) the disclosure is impliedly authorized to carry out the representation; or (iii) the disclosure is permitted or required by the West Virginia Code of Professional Responsibility. Lewis Glasser may, consistent with the West Virginia Code of Professional Responsibility,

reveal non-confidential information shared with Lewis Glasser on your behalf and in pursuit of your objectives.

- (B) You acknowledge that certain legal "privileges" at law may attach to communications between Lewis Glasser and you depending on the circumstances and substance of the communication and the parties to whom the communication was made. You are advised that the attorney-client privilege is not universal, is not unconditional, cannot be established simply by copying a lawyer on an e-mail message or other communication, and is otherwise limited by law. You acknowledge that when the privilege does exist, you (even inadvertently) might limit or waive it by sharing privileged information or communications with parties to whom the privilege does not extend. You agree to confer, in advance, with Lewis Glasser if you have questions regarding the scope of the privilege.
- (C) You understand and agree to these terms and conditions regarding the privilege and confidentiality.
- 12. Possible Conflicts: Lewis Glasser is not aware of any actual conflicts of interest in connection with this matter. We will inform you of any conflicts that may arise during our representation of you in this matter. To the fullest extent possible, based upon any applicable law, you hereby waive any existing conflicts or any conflicts that may arise in the future. Where required by applicable law or rule, Lewis Glasser will disclose to you any close friendships that lawyers at Lewis Glasser, who are active on this matter, may have with opposing legal counsel or adverse parties. Should we disclose any such relationships, the continuation of our attorney-client relationship following such disclosure shall indicate Client's acceptance of such relationship and willingness to continue with Lewis Glasser as counsel. Nothing in this Section shall alter any of the terms of Section 10 on confidentiality or privilege.

#### 13. Work Product: Marks:

- (A) Work product generated by Lewis Glasser remains the sole and exclusive property of Lewis Glasser. You may reproduce or use the work product as necessary for your internal business purposes or, in the case of a transaction, for the negotiation and conclusion of the transaction that is the subject of the representation. Lewis Glasser's work product shall not be shared with third parties, except as permitted by this Section, and any copies produced by you in accordance with this Section nonetheless remain the property of Lewis Glasser.
- (B) You may have access to material, including graphic images and texts, that is used by Lewis Glasser to identify Lewis Glasser or Lewis Glasser proprietary materials (the "LG Marks"). The LG Marks may not be copied, reproduced, republished, uploaded, posted,

transmitted, or distributed in any way, without the prior written permission of Lewis Glasser.

- 14. Electronic Communications: You specifically authorize communication of all matters related to the contemplated representation via electronic forms of communication including, but not necessarily limited to, email messages, attachments to email messages, facsimile, electronic data room or file sharing programs, and voice over IP. You represent that (i) you are fully aware of the potential risks related to electronic loss, interception or theft of this data and (ii) Lewis Glasser has made no representations or warranties regarding the effectiveness of security measures taken to ensure data security. Because of the nature of data security, you release Lewis Glasser from any claims or causes of action that you might have related to any loss of data, for whatever reason, or the associated loss of any privilege that may attach to communications between Lewis Glasser and you that might result from such data loss.
- 15. Disputes. Any dispute arising under this agreement will be submitted to arbitration in Charleston, West Virginia by the West Virginia State Bar under its Voluntary Fee Dispute Resolution Program, if regarding fees, or by an arbitrator to be agreed to by the parties, if regarding any other matter. Alternatively, you may choose to arbitrate any dispute arising under this letter agreement in Charleston, West Virginia by a single arbitrator provided through the American Arbitration Association. The decision of any such arbitrator shall be binding, conclusive and not appealable. If a dispute is not or cannot be arbitrated, the parties consent to the jurisdiction of and venue in the courts of Kanawha County, West Virginia.
