

Dear Commission Members:

We are here today to formally request that you reverse your decision to grant a variance to Greg Hicks in order to build a video lottery establishment on his property located on Waverly Road outside of Williamstown. There are several reasons that the granted variance is illegal and should be reversed immediately. These are: 1) The establishment will be immediately next to a divided highway 2) the establishment is on a dangerous section of Waverly Road which has been proven to be hazardous 3) the establishment is within 1,000 feet of several residences 4) the establishment is within 100 feet of property used as a recreational area 5) the establishment was granted a variance contrary to the recommendation of Sarah Robinson, Compliance Officer for Wood County, who stated that "In light of these findings I am recommending that this application be denied, as it does not fit the Land Use Provisions as set forth in the Ordinance". The ordinance she refers to is section 4 Land Use Provisions. For these reasons, we formally request that you reverse your decision.
