At 9:30 A.M., the County Commission of Wood County met in regular session. They signed purchase orders, invoices and other correspondence.

The County Commission, upon a motion made by David Blair Couch, seconded by Robert K. Tebay and made unanimous by James E. Colombo, approved minutes of August 23, 26 and 30, 2021.

AGENDA AND DISCUSSION ITEMS

At 9:30 A.M., Wood County Prosecuting Attorney, Pat Lefebure, met with the County Commission to request the County Maintenance Department create an office area for his new investigator. The County Commission, upon a motion made by James E. Colombo, seconded by Robert K. Tebay and made unanimous by David Blair Couch, did hereby authorize this request. (Order A/2447)

At 9:42 A.M., representatives from the Mid-Ohio Valley Airport met with the County Commission to update them on the economic impact it has on the area. They asked for funds to assist them in repairs and renovations at the airport. The County Commission stated they would vet the idea through their attorneys to see if it qualifies for the American Recovery Plan funding.

At 10:26 A.M., the County Commission opened sealed bids for the restoration of the Courthouse bell. Said sealed bids were received pursuant to a Legal Notice appearing in the Parkersburg News and Sentinel on August 18, 2021. Sealed bids were received from the following: The Verdin Company - \$47,135.00 and Chime Master - \$30,000.00 with Add on #1 - \$5,000.00 and Add on #2 - \$6,000.00. The County Commission of Wood County, upon a motion made by Robert K. Tebay, seconded by James E. Colombo and made unanimous by David Blair Couch, did RECEIVE said bids for review. (Order A/2445)

At 10:31 A.M., Lindsey Piersol, Wood County Development Authority Director, met with the County Commission and updated them on proposed development in Wood County.

At 11:13 A.M., the County Commission met with Sarah Robinson, Compliance Officer, to discuss bids for the demolition and cleanup of 66 Blaze Run Road, Walker, WV. Mrs. Robinson stated Jimmy Harper Construction was the lowest price.

At 11:18 A.M., the County Commission upon a motion made by David Blair Couch, seconded by James E. Colombo and made unanimous by Robert K. Tebay, placed, Chris Swarr, representing the Wood County Parks; Roger Sheppard, representing private landowners; and Dave Smith, representing the West Virginia Department of Transportation, in nomination for reappointment to the Wood County Alternative Transportation System Council. The new terms will expire July 15, 2023. (Order A/2444)

At 11:20 A.M., the County Commission approved the hiring of Talena Giffen as a court transport officer for the Sheriff's Department.

At 11:21 A.M., the County Commission discussed the need to dredge Mountwood Park Lake. They asked the County Administrator to find the funding for the project.

Having no scheduled appointments or business to attend to, the County Commission
adjourned at 11:24 A.M.
