At 9:30 A.M., the County Commission of Wood County met in regular session. They signed purchase orders, invoices and other correspondence.

The County Commission, upon a motion made by James E. Colombo, seconded by Robert K. Tebay and made unanimous by David Blair Couch, approved minutes of December 20, 23, 27 and 30, 2021 and January 3, 6 and 10, 2022.

**AGENDA AND DISCUSSION ITEMS**

At 9:30 A.M., the County Commission met with Mark Lewis, Director of the Convention and Visitors Bureau. Mr. Lewis gave the Commission an update on the Bureau and their upcoming purchase of the Point Park Marketplace building.

At 10:00 A.M., the County Commission met with Liz Ford and Doug Hess, representatives from the ARC. They gave an update on their organization. After discussion, the County Commission, upon a motion made by David Blair Couch, seconded by James E. Colombo and made unanimous by Robert K Tebay, did hereby AUTHORIZE a donation of thirty thousand dollars and zero cents (\$30,000.00) to The Arc of the Mid-Ohio Valley. (Order C/108)

At 10:10 A.M., the County Commission met with Mark Rhodes, Wood County Clerk. He presented the redistricting of precincts for elections. The County Commission upon a motion by Robert K. Tebay, seconded by James E. Colombo and made unanimous by David Blair Couch, did hereby AUTHORIZE the redistricting of Voting Precincts in the County. Said changes were proposed and presented to the County Commission by Wood County Clerk, Mark Rhodes. (Order C/107)

At 10:32 A.M., the County Commission met with Rick Woodyard, Sheriff, who requested their permission to hire an evidence technician and liaison the State Fusion Center. The County Commission, upon a motion made by David Blair Couch, seconded by James E. Colombo and made unanimous by Robert K. Tebay, did hereby authorized the hiring of an evidence technician for the Wood County Sheriff's Office. (Order C/109)


Having no scheduled appointments or business to attend to, the County Commission adjourned at 10:48 A.M.
