Afternoon Marty,

I would like to set aside a time that I could speak to the Commission in regards to the Help Wanted add that went out to all County employees today from the County Clerk's Office. The add is at the bottom of this email.

It shows that this position will start out at \$34,800.00. The concern I have is that 7 employees that have been here from 2016 to 2021 are not making close to this even with the new approved raises for the 2022 Budget year.

The Deputy that has been here 7 years makes 32,832.00 a difference of \$1968 and 7 years of service. Two deputies have been here since 2018 and make 30,698.00 a difference of \$4102 with 4 years of service.

Three deputies that have been here since 2020 make \$30,630 a difference of \$4170. The last employee hired in 2021makes \$30,398.00, a difference of \$4402.

This is a substantial difference from a new employee just starting out in the County Clerk's Office. After reviewing the job description for this open County Position, it does not intel any more responsibilities than what the positions my Deputies have.

I would like to talk to the Commission about this and be given a reason why a new employee with same level of job responsibilities comes in making that much more than others in the County.

I appreciate your consideration looking at this issue and look forward to meeting with the Commission very soon to discuss this matter.

I am out next week from Sunday until Wednesday for the Circuit Clerk Conference, but available any time after that.
