



To the Honorable Jim Justice:

GOVERNOR OF THE STATE OF WEST VIRGINIA

I have the honor to request that you issue a requisition to the Governor of the State of Ohio for the extradition of Timothy M. Sampson who stands charged with Count One: Fleeing from an Officer in a Vehicle with Reckless Indifference; and Count Two: Fleeing a Police Officer, which offenses were committed in the County of Wood, of this State, in October, 2020, and who is now a fugitive from justice of this State and, as I am informed, is now within the jurisdiction of the said State of Ohio, in the County of Washington. The date of birth of said Timothy M. Sampson, is 09/25/1991; social security number _____ a white male, 5'8", 160 pounds, brown hair and brown eyes.

I HEREBY CERTIFY:

1. That the full name of the person for whom requisition is asked is Timothy Sampson who will be hereinafter referred to as said accused.
2. That said accused was personally and physically present in this State at the time of the commission of said crimes, and to avoid arrest and prosecution, fled from the jurisdiction of this State.

3. That in my opinion the ends of public justice require said accused to be brought to this State for trial at the public expense, and I believe I have sufficient evidence to secure the conviction of said accused of said crimes.


4. That this request is made in good faith and not for the purpose of collecting a debt or for any private purpose whatever, and if the requisition now applied for be granted, criminal proceedings shall not be used for any of said objects.

5. That no former application for a requisition for said accused, growing out of the same transaction, has been made.
