This is a continuation of a hearing held on May 19, 2022.

At issue is Ms. Taylor's requests of Elective Share of the estate of Carl Taylor.

The estate was referred to Fiduciary Commissioner Will Creighton concerning the Elective Share. Mr. Creighton filed and NOTICE OF DELINQUENCY and a required Ms. Taylor to post a bond before a hearing was held on December 28, 2021. The ORDER was approved by the Wood County Commission on January 6, 2022.

Mr. Fluharty filed a Motion to Disqualify Mr. Creighton a hearing was scheduled for March 17th and Mr. Creighton resigned prior to the hearing.

The County Commission continued the hearing to permit Prosecutor Pat Lefebure time to review the case and advise the legal procedure for an Elective Share.

The Commission after hearing arguments from both side and advise from Mr. Lefebure, ORDER the matter be referred to Justin Hardman, Fiduciary Commissioner. The Commission future ORDERED Ms. Taylor be required to post a bond in the amount set by the Fiduciary Commissioner. The Commission ORDER if Ms. Taylor prevailed, she could be reimbursed from the proceeds of the sale of the residence. The proceeds are being held in escrow by Attorney David Palmer.
