

As per your request a meeting was held to come up with a list of suggestions to help remedy the problem of ambulance availability in Wood County. Wood County fire departments and the two ambulance providers were invited to the meeting. Eight of the eleven fire departments and St. Joe Ambulance attended with Camden Clark Ambulance declining until they officially hear from the Commission with concerns of lack of coverage. Camden Clark sent an email that I will read.

During the meeting several ideas were talked about. One of the main problems is the extended wait times when dropping off a patient at the hospitals, there have been up to 6 hour waits before the hospital will accept the patient. After a lengthy discussion concerning this, it was mentioned there is a Federal law concerning when a patient becomes the hospitals responsibility. This is something that needs to be discussed with the local hospital.

Listed below are other items discussed (not in any prioritized order)

1. Wood Co. ambulances need to handle local calls instead of going to other counties that are unable to handle their own calls on a normal basis. (not including mass casualty incidents or occasional mutual aid calls)
2. There needs to be a formal agreement between the County and the ambulance providers for the amount of units in service per shift.
3. Have agreement with other private ambulance providers to respond to overflow 9-1-1 calls.
4. Calls need to be triaged during dispatch or by ALS providers in the field.
5. The last ambulance available should not go on a transfer or out of the county.
6. Public education with local media and social media of how to properly use the 9-1-1 system and not abuse it for non-emergency calls.
7. Possibility of a regional response system (St Joe Ambulance mentioned this and has information).
8. There needs to be a better way for billing and reimbursement of public assist or non-transport calls to the ambulance providers.
9. Personnel/staffing problems. As with everything else today, it is hard for ALS and fire departments to get proper staffing without over working the people you have now.

It may be possible for the County Commission to take Camden Clark's offer to help fund a 3<sup>rd</sup> party review to see if any of these suggestions could be addressed to help you meet your obligation to provide ambulance service to the citizens of Wood County.

I would like to thank you Commissioners for listening to our concerns.



**Whereas**, *domestic violence does not discriminate and touches all communities regardless of age, disability, race, gender identity, and socioeconomic status; and*
