AGENDA AND DISCUSSION ITEMS

At 9:30 A.M., the County Commission, sitting ex-officio, as the Board of Canvassers, to ascertain the results of the Canvass for the General Election held on November 8, 2022, in the County of Wood. Having carefully and impartially examined the returns of the aforesaid Election, and there being no contests pending, the Board of Canvassers, upon a motion made by Robert K. Tebay, seconded by James E. Colombo and passed, does hereby CERTIFY the statewide and Wood County election results and do now declare the Canvass closed. The Clerk of the County Commission of Wood County is now directed to certify the results of said election to the Secretary of State, Charleston, West Virginia. The County Commission, upon a motion made by Robert K. Tebay, seconded by James E. Colombo and passed, does hereby adjourn as the Board of Canvassers, sine die. (Order A/2657)

At 9:35 A.M., the Prosecuting Attorney, Pat Lefebure, met with the County Commission to request additional funds to hire an attorney in his office. After discussion, the County Commission, upon a motion made by Robert K. Tebay, seconded by James E. Colombo and passed, did hereby AUTHORIZE an additional amount of fifteen thousand dollars and zero cents (\$15,000.00) to be added to the Assistant Prosecutors salary line item in the Wood County General Fund budget. Said funds are contingent upon the hiring of a new Assistant Prosecutor who would require a higher salary than the current vacated position allows. (Order A/2655)

At 9:39 A.M., upon motion of Robert K. Tebay, seconded by James E. Colombo and passed, the County Commission, upon prior adjournment of the regular session, convened in EXECUTIVE SESSION upon authority granted by the West Virginia Code, Chapter 6, Article 9A, Section 4, Subsection 7, as amended: WHEREUPON, the said Robert K. Tebay and James E. Colombo, Commissioners met with Marty Seufer, County Administrator. All those present proceeded to discuss the matter for which the said EXECUTIVE SESSION was had, regarding investment of public funds. The Commission having concluded said discussion, the said EXECUTIVE SESSION adjourned at 9:42 o'clock A.M. (A/2656)

IN RE: ESTATE OF WILLIAM BRUCHEY

ORDER

The County Commission sitting as Probate Court held a hearing Thursday, November 10, 2022 on a Petition to Remove Executrixes in the estate of William Bruchey. The Petition was filed by Jeffrey B. Reed, Counsel for Petitioners, Debora Galford, Ruth Stephens, Pamela Mitchell, Elizabeth Stephens and Jane Powell, all present.

Justin Raber appeared as counsel for the Co-Executrixes, Mary Kay Blank (present) and Peggy Ann Hess (absent).

Mr. Reed's argument for removal centered on the Co-Executrixes not moving forward with the sale of the real estate.

Mr. Raber stated the case was moving forward and an accounting had been submitted to Mr. Reed and a partial distribution had been made to the beneficiaries.

The beneficiaries and executrixes were questioned if they were in agreement to sell the real estate and if they all would sign the deed to transfer to the new owner. All except Ms. Galford stated they would sign the deed.

The County Commission has no legal authority to ORDER real estate involved in an Estate be sold and recognizes that Paragraph Six authorizes and empowers the sale of the real estate by said Executrix.

Previously, Pamela Diane Mitchell, when making her selection of what she wanted of the decedent's property, she chose not to take any interest in the real estate.

The County Commission, sitting as Probate Court, upon a motion of Robert Tebay, seconded by

James Colombo and made unanimous by David Couch, directs the Executrix(s) as authorized by the Last Will and Testament of William Bruchey to sell said real estate with the proceeds to be divided four ways, specifically, to Ruth Ann Stephens, Jane Marie Powell, Elizabeth Sue Stephens, and Debora Ann Galford, in equal shares as set out in the June 13, 2022, letter sent by their counsel to the County Commission, and in accordance with the Fiduciary Commissioner's ruling entered into Court records September 9, 2022. It specifically being recognized that Pam Mitchell is not an owner of said real estate.

The motion also continued Justin Hardman as Fiduciary Commissioner.


The motion also directed that if the real estate was not disposed of in thirty days, the Co-Executrixes were to be removed and the Sheriff of Wood County would be appointed to settle the estate.

Both parties were informed the decision could be appealed to the Circuit Court.


