1. Fabricate and install (12) 6" schedule 40 bollards spaced no more than 54" on center per the detail provided by the power company. Bollards to be 8' long and embedded 54".
2. Saw cut asphalt, excavate, and place a 3" sand bedding for the junction box pad foundation.
