At 9:30 A.M., the County Commission of Wood County met in regular session. They signed purchase orders, invoices and other correspondence.

Leslie Board took her oath as a Criminal Investigator for the Wood County Sheriff's Office. Jeff Kidder was sworn in as Sargent for the Wood County Sheriff's Office and Derek Cross was sworn in as Lieutenant for the Wood County Sheriff's Office.

**AGENDA AND DISCUSSION ITEMS**

At 9:30 A.M., the County Commission held a hearing in regard to the Estate of Carolyn Hart. Jeffrey Hart, Administrator of the Estate was present. After discussion and a request to have a claim disallowed, the County Commission, upon a motion made by David Blair Couch, seconded by James E. Colombo and passed, disallowed the claim.

At 10:00 A.M., the County Commission held a Public Hearing in regard to the Application to apply for CDBG funds in regard to Hill Avenue. Two residents of Hill Avenue were present but did not have input. Also in attendance was Eric Bennett, Parkersburg Utility Board Manager, Katrina Kratche, Project Coordinator and Luke Peters from the Mid-Ohio Valley Regional Council. After discussion, the County Commission of Wood County, upon a motion made by

Colombo and made unanimous by David Blair Couch, did hereby AUTHORIZE David Blair Couch, in his official capacity as President and on behalf of the County Commission, to EXECUTE an Application for a Community Development Block (CDBG) Grant with the West Virginia Department of Economic Development for the Hill Avenue Sewer Project. (Order A/2713)

At 10:05 A.M., the County Commission met with Lindsey Piersol, Wood County Development Authority and Ryan Barber, City of Parkersburg. They discussed the Limited Exemption from Personal Property Taxes Program. The Commission will discuss this further with the Assessor's Office.

The County Commission of Wood County, upon a motion made by Robert K. Tebay, seconded by James E. Colombo and made unanimous by David Blair Couch, did hereby AUTHORIZE David Blair Couch, in his official capacity as President and on behalf of the County Commission, to EXECUTE a Limited Exemption From Personal Property Taxes Agreement regarding Ohio Valley Top Shop. The County Commission approved the hiring of Nathaniel W. Simonton as a Telecommunicator for the E-911 Center.

There were no walk-ins or appointments for the Board of Review and Equalization.



**LIMITED EXEMPTION FROM  
PERSONAL PROPERTY TAXES AGREEMENT**

This is an Agreement for Limited Exemption from Personal Property Taxes, made and entered into on this the \_\_\_\_ day of \_\_\_\_\_, 2023, by and among Ohio Valley Top Shop, ("Top Shop") a West Virginia corporation; the COUNTY COMMISSION OF WOOD COUNTY, WEST VIRGINIA, a public body (the "Commission"); David Nohe, in his official capacity as WOOD COUNTY ASSESSOR ("Assessor"); the Commission, and the Assessor acting on behalf of WOOD COUNTY, WEST VIRGINIA (the "County").

WHEREAS, Ohio Valley Top Shop has entered into an Equipment Lease Agreement (the "Lease"), dated \_\_\_\_\_, whereby Ohio Valley Top Shop will lease from the Wood County Development Authority ("WCDA") certain equipment for its manufacturing facility situate at Parkersburg, Wood County, West Virginia;

WHEREAS, WCDA is not required to pay personal property taxes on equipment;

WHEREAS, Ohio Valley Top Shop has agreed that the Equipment Lease will add 12-18 full-time jobs or their equivalency in Wood County, West Virginia, and the WCDA is willing to enter into the Equipment Lease for the purpose of supporting the growth of Ohio Valley Top Shop and the creation of jobs in Wood County, West Virginia;

WHEREAS, it is the desire and intention of the parties to exempt Ohio Valley Top Shop from personal property taxes for the five-year lease term and so long as Ohio Valley Top Shop employs 12-18 -time employees in their organization;

NOW, THEREFORE, WITNESSETH: That for valuable considerations, the receipt of all of which are hereby acknowledged, it is hereby agreed as follows:

1. Property Comprising the Project Exempt from Property Taxes. During the term of the Lease, the freehold interest of WCDA in the personal property, which is the subject of the Equipment Loan, shall not be subject to any personal property taxes, the same being exempt by operation of law.

2. Leasehold Interest Assessed and Taxed at Nominal Value. The leasehold interest of Ohio Valley Top Shop created by the Lease is not freely assignable and therefore has no separate taxable value. Nevertheless, under this Agreement the leasehold shall be subject to assessment and shall be entered accordingly on the property books of the County provided however, that the assessed value of the leasehold shall be at the nominal value of One Dollar (\$1.00) only for such Lease.

3. Exemption from Personal Property Taxes.

A. NOTWITHSTANDING ANYTHING IN THIS AGREEMENT TO THE CONTRARY, OHIO VALLEY TOP SHOP SHALL HAVE NO OBLIGATION TO PAY PERSONAL PROPERTY TAXES ON THE EQUIPMENT, SUBJECT TO THE EQUIPMENT LEASE FROM THE WCDA TO OHIO VALLEY TOP SHOP UNLESS ITS FULL-TIME EMPLOYEES, OR THEIR EQUIVALENTS, NUMBER LESS THAN 15.

B. *Failure to Employ 15 Full-Time Employees or Their Equivalent:*

(1) In the event Ohio Valley Top Shop falls below 15 full-time employees or their equivalent for any year, the WCDA shall request the Assessor to provide a tax assessment for the equipment which shall be charged to Ohio Valley Top Shop under the terms of the Lease, and upon receipt from Ohio Valley Top Shop paid to the Sheriff of Wood County by the WCDA

(2) The amount due in accordance with Section 3.B.(1) above shall be reduced by an amount equal to any tax payable as, determined by the West Virginia State Tax Commissioner, or by the Assessor, with respect to Ohio Valley Top Shop's leasehold interest in and to the Project or the Lease, without regard to the reason for, or basis of, such determination.

(3) For purposes of this Section 3, the term "Project" shall be defined to include any expansions thereto, while titled in the name of the WCDA whether or not described or subject to any lease other than the Lease or subject to payment in lieu of personal property taxes under the terms of an agreement other than this Agreement.

C. *Comparable discounts, penalties and interest apply.* With respect to the payments to be made hereunder, Ohio Valley Top Shop shall be entitled to discounts comparable to those available by operation of law for early payment of personal property taxes, including, but not limited to, any available statutory early payment discount. Likewise, Ohio Valley Top Shop shall be responsible for the payment of any penalties and/or interest comparable to those payable by operation of law for delinquent personal property taxes in connection with any late payment of its obligations hereunder.

4. Credit for Payments Made. In the event that any amounts are paid by Ohio Valley Top Shop as personal property taxes levied by the County on its leasehold interest in the Project, such amount shall be fully credited against and reduce the payments in lieu of taxes otherwise due pursuant to Section 3 herein, likewise Ohio Valley Top Shop shall be entitled to a refund of the same from the County by virtue of any overpayment thereof resulting from such credit and reduction.

5. Term. This Agreement shall continue until such time as Ohio Valley Top Shop exercises its right to purchase the Project from the WCDA or a period of five (5) years from \_\_\_\_\_, 2023, whichever event occurs first.

6. Construction. It is the intention of the parties in entering into this Agreement to provide for certainty in the assessment of personal property taxes payable by Ohio Valley Top Shop, to provide an inducement for Ohio Valley Top Shop to invest in the Project in

the County, to clarify ambiguities as to the appropriate assessment of Ohio Valley Top Shop's leasehold interest in the personal property to be leased by WCDA to Ohio Valley Top Shop, and to provide for payments in lieu of taxes to the Sheriff for educational purposes as an inducement to enter into this Agreement. It is the intention of the parties that this Agreement be construed liberally in order to effect the aforesaid intent of the parties.

7. Miscellaneous. Neither this Agreement nor any provision hereof may be amended, modified, waived, discharged or terminated orally, except by an instrument in writing signed by the parties hereto. The provisions of this Agreement shall be binding upon the successors and assigns of each of the parties. The captions in this Agreement are for the convenience of reference only and shall not define or limit the provisions hereof.

8. Governing Law. This Agreement shall be governed by and construed in accordance with the laws of the State of West Virginia.

9. Condition to Agreement Becoming Effective. Notwithstanding any other provision herein, this Agreement shall not become effective unless and until title and ownership in and to the Project is transferred to and held by the WCDA. In the event that ownership of the Project is not held by the WCDA, it is expressly acknowledged that this Limited Exemption from Personal Property Taxes Agreement executed by the parties hereto, shall be null and void.

10. Severability. The parties hereby agree that in the event one or more portions of this Agreement shall be declared invalid by appropriate authority, the remaining provisions of this Agreement shall continue in full force and effect, provided however, that should the aggregate personal property taxes paid by Ohio Valley Top Shop to the County, with respect to the Project and the leasehold interest of Ohio Valley Top Shop in the Lease, in any one year after the tax year 2023, exceed the payments in lieu of taxes provided for in section 3 herein (prior to adjustment as provided in section 4 herein), then, at the election of Ohio Valley Top Shop, in its sole discretion, this Agreement may be canceled and rendered void and of no further force and effect from and after the date on which such taxes are paid.

11. Rights of Ohio Valley Top Shop to Challenge Assessments. Nothing herein shall be deemed to prohibit Ohio Valley Top Shop from challenging any assessments made against it by the County before the Commission sitting as a Board of Equalization and Review, or as otherwise provided by law, the rights of Ohio Valley Top Shop herein being deemed to be cumulative and not in lieu of said rights of appeal and other legal rights.
