AGENDA AND DISCUSSION ITEMS

The 9:30 A.M. discussion on Mountwood Park is being rescheduled.

The County Commission, upon a motion made by David Blair Couch, seconded by James E. Colombo and made unanimous by Robert K. Tebay, announced that vacancies exist on the Wood County E9-1-1 Advisory Board. Said vacancies are due to the fact that the terms of Chief Mike Pifer (City of Vienna), Steve Stephens (Wood County Sheriff's Department), Charles Meyers (Wood County Firefighters Association), Jack Horton (Media), Lew Peck (Wirt County Commission) and Rick Woodyard, Director of the Multi-County E-911, will expire April 30, 2023. The County Commission, upon a motion made by David Blair Couch, seconded by James E. Colombo and made unanimous by Robert K. Tebay, appointed Malorie Chadock, representing Substance Abuse Services, to the Wood County Community Corrections Advisory Board. She will be filling an unexpired term that will expire December 31, 2024. (Order A/2744)
