I recently made the request to hire a temporary, part-time employee for 8-10 weeks to cover a Front Office/Drug Screening position while my full time employee is on maternity leave. The Commission approved that request. However, WV Drug Testing Laboratories is losing one their full time employees and after discussion with the Operations Director, Jana Singer, it was decided that it would better meet both agencies needs to hire one full time person and split the cost between the Lab and the DRC. This young lady would conduct all front office and drug screening responsibilities for the next 3 months. After Amanda returns from maternity leave, she will be able to provide assistance during busy times, she will be able to cover when Amanda is on vacation or sick, she will cover for Jana and Jorun when they are on vacation or sick, and once trained, she will assist in training incoming employees. She will also provide essential services to the WV Drug Testing Laborites on a daily basis.

Please regard this notice as my request to hire Kyla Farmer as a full-time, Front Office Assistant for the Wood County Day Report Center at the rate of \$27 per hour (\$56,162.16). Half of her salary will be reimbursed to the Wood County Commission by the WV Drug Testing Laboratory. Since we will not be hiring the "temporary/part-time" position and I have requested to hire Mr. Richards (in place of Mr. Butler) at a lower rate of pay, as well as not replacing Lindy Lemley's part time position, we will have money available in our budget to cover our half of Ms. Farmer's salary.

Ms. Farmer has 15 years of experience through WVU Medicine Camden Clark. Prior to that she was formerly employed with us on a part-time basis, at our Market Street location. She is familiar with the operation procedures of the Day Report Center and the population we serve. She has an Associates Degree in Applied Science and would be a great asset to both agencies.

If this request is approved, she is able to start on May 30, 2023
