ORDER APPROVING AMENDED FINAL SETTLEMENT

On the 10th day of August 2023 came Mark Furner, a beneficiary of the estate of Betty Lucille Scritchfield, deceased, Kristi Edwards, Administratrix CTA, in person and by counsel C. Blaine Myers.

The Administratrix thereupon presented to the Commission a proposed Amended Final Settlement, which included some additional attorney fees incurred for the benefit of the estate, but also eliminated certain expenditures which were inadvertently included in the original Final Settlement, but which had actually been paid from the sale of real estate. The Amended Final Settlement therefore slightly increased the distributions due to the three beneficiaries.

Upon consideration of the representations and arguments of the parties, the Commission is of the view that the Amended Final Settlement of the estate should be and is hereby ORDERED approved.


