

Honorable Commissioner's

In addition to the Circuit Clerk's office not renewing the contract with AS 400, it will be also eliminating the maintenance fees in the amount of \$5532.00 per year.

I also applied for a project with the Supreme Court to have old felony files preserved and digitized. They approved our office for the project and will be coming on site August 30, 2023, to assess the records and set a pickup date. This project will be for all felony records from 1992 to 2015. This is over 5,000 records they will digitize and preserve. Once this is done, they will also be responsible to destroy the records which is cost saving measures for the county also.

Aaron Parsons is the newly appointed person at the Supreme Court Archives Division, I contacted him about all our old Chancery files. I ask him if he was able to come and take all of them and permanently preserve and store them at their facility, since they are deteriorating in the storage we had. He is coming September 6, 2023, to look at the records and then we will decide a date for them to come pick them up, he will sign off on all the records he is taking and take full responsibility for them. He did make a request and ask the day they come if they could have some extra manpower helping to get them loaded and ready for transport, there are 55 cabinets full of the Chancery files to pack up and move.

All these records will be picked up and moved by mid-September, this will empty 3 of the rooms at the Sheriffs' building. The Archives Division passed an updated Retention Schedule, and all digitized records are now considered a permanent record. My office has made a huge dent in digitizing case files and by mid-2024 we should have all the remaining records in the Sheriff's office Digitized. We will continue to work at getting this building emptied.
