PROCLAMATION

National Crime Victims' Rights Week, April 21-27, 2024

Whereas being a victim of crime and navigating the criminal justice system can be a frightening and confusing experience;

Whereas National Crime Victims' Rights Week provides an opportunity to recommit to ensuring that accessible, appropriate, and trauma-informed services are offered to all victims of crime; and Whereas the Prosecuting Attorney's Office of Wood County is hereby dedicated to supporting victims and survivors in the aftermath of crime, building trust among our clients; collaborating with other service providers, and engaging our community in response efforts;


