





The Commission FINDS that the current courtroom facilities are of an inadequate size for certain proceedings and that it may be necessary from time to time to conduct hearings and or trials in a larger facility within the County.


West Virginia Code 51-3-7 states that "Every circuit court, county court and other court of record of any county shall be held at the courthouse of such county, except where some other place is prescribed by law or lawfully appointed. When the courthouse of a county is destroyed or is not in a condition to be occupied, such court shall hold its sessions at such places as may be appointed by order of the county court. A copy of such order or warrant shall be posted by the clerk of the county court at the front door of his office, at the courthouse door, unless the courthouse has been destroyed, and at the place so appointed."

It is therefore ORDERED that the Wood County Resiliency Center is hereby designated as additional courtroom facility which may be used, upon request, by the Courts when necessary to conduct jury trials and other proceedings in which the regular courtrooms are unable to be used due to the inadequate size of the existing courtroom facilities.



It is further ORDERED that a copy of this Order shall be provided to the Wood County Circuit Clerk.


