Dear Honorable Commissioners:

The Shred project from the old sheriff's office has concluded. There were 6 county offices that participated in it. Circuit & County Clerk, Sheriff & Sheriff Tax Office, Prosecuting Attorney, and the Assessor's Office. Gator Shredding was the Company that was on site for 3 days for this shred. They had 503-96-gallon containers- 9,604# of books- 287# of x-rays and tapes- 2,280# of evidence. The crew we worked with from Gator was amazing. They all worked very hard and did not stop. The items that were for shred from my office were files that had all been digitized and scanned and any evidence that could be scanned and preserved was. All other items were destroyed under the guidelines of the Retention Schedule. The Archives Division has signed off on all the Authorization to Destroy Record forms that I submitted so I have them for the record.

My office and the PA's office had most of the shred, and then the others had a fair amount. I can say that building must feel a whole lot lighter after this was all done. After seeing what all came out of this place those 3 days, the building held up very well.

The following week for 3 days, Pace Shredding was on site to complete the shred project. There were 3 storage rooms full of file cabinets and boxes that had all been scanned and digitized. We had a total of 115 -96-gallon containers for shred out of my office. The PACE crew was not pleasant to work with and unprofessional. I did call the Sales Rep that placed the bid for the project and discussed this with him. He did apologize and said he would address his crew. I am so thankful I chose Gator to handle the shred at the Sheriff's Office – there is no way that PACE could have handled that job, and it would have turned into a mess.

This has been a huge inherited milestone to overcome, and I can honestly say I am elated for it to be behind me and my office. It took just a few months less than 4 years to complete, but it was a goal I had set to achieve and accomplish the day I was sworn to take office. The Deputy Clerk's worked very hard to help me accomplish this.

The next step for us to finish their completely will be to get all the empty cabinets moved out of the 3 storage rooms within my office. Once this is completed, then we will move all the other cabinets from there that still need digitized and scanned. We will move the shelving from there to put our permanent order books on that are a permanent record and can't be destroyed. All that will be left at the building of ours will be all the empty file cabinets.

Once this step is complete, I will be using file room # 3 in my office to move all the RIS files here for us to start scanning and digitizing, that will rid us of the \$1,000 monthly bill we pay for the off-site storage of them.

Thank you all for all the support and help with this project.
