AGENDA AND DISCUSSION ITEMS

At 9:30 A.M, Toni Tiano, Grant Writer and Sheriff Rick Woodyard met with the County Commission to request they apply for a Bulletproof Vest grant and a School Resource Officer grant.

The County Commission of Wood County, upon a motion made by Robert K. Tebay, seconded by James E. Colombo and made unanimous by David Blair Couch, did hereby AUTHORIZE the Wood County Sheriff's Office to apply for a Bulletproof Vest Grant with the U.S. Department of Justice. (Order A/3027)

The County Commission of Wood County, upon a motion made by Robert K. Tebay, seconded by James E. Colombo and made unanimous by David Blair Couch, did hereby AUTHORIZE David Blair Couch, in his official capacity as President and on behalf of the

County Commission, to EXECUTE an Application for a Justice Assistance (JAG) Grant with the West Virginia Department of Justice. Said grant application is in the amount of twenty-eight thousand dollars and zero cents (\$28,000.00) and is for a School Resource Officer (SRO) for the Wood County Sheriff's Office. (Order A//3024)

At 9:47 A.M., Sheriff Woodyard asked the County Commission to go out to bid for six police vehicles. After discussion, the County Commission of Wood County, upon a motion made by James E. Colombo, seconded by Robert K. Tebay and made unanimous by David Blair Couch, did hereby AUTHORIZE the Wood County Sheriff to seek bids for six (6) Law Enforcement Vehicles. (Order A/3026)

At 9:51 A.M., Lindsey Piersol from the Wood County Development Authority asked the County Commission to sign a Resolution for an Industrial Access Road at the former Ohio Valley University campus. After discussion, the County Commission, upon a motion made by David Blair Couch, seconded by Robert K. Tebay and made unanimous by James E. Colombo, did hereby EXECUTE a Resolution in support of an application by WVUP Foundation, for an amount not to exceed \$400,000.00 in unmatched funds and \$150,000.00 in matched funds of Industrial Access Road Funding through the West Virginia Development Office and the West Virginia Department of Highways. At 10:11 A.M., the County Commission authored a lien release against the Convention/Visitors Bureau Building.

Tebay, appointed Sean Andrews, Republican, to the Wood County Civil Service Commission for Deputy Sheriffs. The unexpired term will expire June 30, 2025. (Order A/3029)

At 10:22 A.M., in Room 203, of the Wood County Courthouse, Parkersburg, West Virginia, upon motion of David Blair Couch, seconded by James E. Colombo and made unanimous by Robert K. Tebay, County Commissioners, upon prior adjournment of the regular session, convened in EXECUTIVE SESSION upon authority granted by the West Virginia Code, Chapter 6, Article 9A, Section 4, as amended. WHEREUPON, the said Robert K. Tebay, James E. Colombo and David Blair Couch, County Commissioners met with Marty Seufer, County Administrator; Pat Lefebure, Prosecuting Attorney and Joe Gonzales, Wood County Clerk.
