AGENDA AND DISCUSSION ITEMS

At 9:30 A.M. Lindsey Boso from the WVU Extension Office informed the County Commission this is National 4-H Week. After discussion, the County Commission, upon a motion made by James E. Colombo, seconded by David Blair Couch and made unanimous by Robert K. Tebay, did hereby EXECUTE a PROCLAMATION in regard to National 4-H Week in Wood County (October 7 – 13, 2024). (Order A/3031)

At 9:45 A.M., the County Commission approved the hiring of Katelin Johnson for the Prosecuting Attorney's Office and Keith Barnett and Shelby Babcock as E-911 employees.

At 9:47 A.M., the County Commission of Wood County, upon a motion made by David Blair Couch, seconded by Robert K. Tebay and made unanimous by James E. Colombo, announced that a vacancy exists on the Claywood Park Public Service District. Said vacancy is due to the fact that James Cox's term expires November 1, 2024. (Order A/3035)

The County Commission of Wood County, upon a motion made by David Blair Couch, seconded by Robert K. Tebay and made unanimous by James E.
