(multiple tracts comprising approximately 99 acres as more completely set out in pages 523 and 535 of Deed Book 1366, as recorded in the offices of the clerk of the Wood County Commission, Wood County, West Virginia – more

commonly known as the former Ohio Valley University campus.)

ORDER

This 28th day of October, 2024, came the City of Vienna, a municipal corporation, the Petitioner herein, by Russell J. Skogstad, Jr., its attorney, and WVU at Parkersburg Foundation, Inc. a non-profit corporation, by Steven R. Hardman, its attorney, as the Petitioners, for hearing upon the Petition for Annexation by minor boundary adjustment heretofore filed and scheduled for hearing this day.

WHEREUPON, Counsel for the Petitioners jointly tendered unto the Commission and asked leave to file the Affidavit of Publication evidencing the publishing of the Notice of Hearing as required by West Virginia Code 8-6-5(e), as amended, which Affidavit is hereby deemed proper in all respects and is hereby ORDERED FILED; and

WHEREUPON, Counsel for the Petitioners jointly tendered unto the Commission and filed the Affidavit of RYAN TAYLOR, attesting to the posting of Notice of Hearing with the area proposed to be annexed, which Affidavit, being deemed proper in all respects is hereby ORDERED FILED; and

WHEREUPON, the Commission having reviewed the Petition and the exhibit attached thereto and upon further consideration of the evidence presented and the representations of counsel for the Petitioner, the Commission does hereby make the following Findings of Fact, to-wit:

- 1. The Notice of Hearing as required by West Virginia Code 8-6-5(e), as amended has been properly published according to law and has been prominently posted at not less than five (5) public places within the area proposed to be annexed.
- 2. The area proposed to be annexed is contiguous to the corporate limits of the Petitioner.
- 3. No persons have appeared this day in opposition to the Petition.
- 4. The area to be annexed consists of five (5) tracts of real property located in Wood County comprising the former Ohio Valley University campus and surrounding property.
- 5. No persons reside within or otherwise use or occupy the area sought to be annexed;
- 6. The intended use is its current use for the upper part and for the lower part, a public recreation area.

- 7. An accurate map showing the area sought to be annexed is attached to the Petition and is made a part of the record herein.
- 8. The area sought to be annexed is wholly within the County of Wood and no other municipality has made application to annex the same.
- 9. The proposed annexation is in the best interest of the County of Wood as a whole.
- 10. Each and every statement and allegation contained in the Petition is hereby found to be accurate and truthful.

ACCORDINGLY, and based upon the Findings of Fact herein above set forth, it is duly **CONCLUDED** that-

- 1. The area proposed to be annexed is hereby deemed a proper subject for annexation by minor boundary adjustment by the Petitioners in accordance with West Virginia Code 8-6-1, et seq., as amended, in all respects
- 2. All requirements as to publication and posting have been fully and lawfully satisfied.
- 3. The best interest of the Petitioners and the County of Wood shall be better serve by granting the relief prayed for in the Petition.

ACCORDINGLY, it is hereby **ORDERED** that the area described in the Petition and further described in the map attached to this Order is, and the same is hereby annexed by minor boundary adjustment and incorporated into the corporate limits of the Petitioners. Petitioners shall pay all costs of these proceedings.

I have the honor to request that you issue a requisition to the Governor of the State of Pennsylvania for the extradition of **Jason Lee Hibbitts** who stands charged with:

- 2. That said accused was personally and physically present in this State at the time of the commission of said crimes, and to avoid arrest and prosecution, fled from the jurisdiction of this State.

3. That in my opinion the ends of public justice require said accused to be brought to

this State for trial at the public expense, and I believe I have sufficient evidence to secure the

conviction of said accused of said crimes.

4. That this request is made in good faith and not for the purpose of collecting a debt

or for any private purpose whatever, and if the requisition now applied for is granted, criminal
