## ORDER REINSTATING LETTERS OF AUTHORITY FOR THE LIMITED PURPOSE OF FINALIZING THE PENDING WRONGFUL DEATH ACTION

## STATE OF WEST VIRGINIA, COUNTY OF WOOD, to-wit:

This matter came before the Wood County Commission on the 30th day of , 2034, when it was represented to the County Commission that after No/ the completion of the time for the presentation of claims and after all probate matters were fully administered in the above-referenced estate, because no further action was needed to be taken by the executor and personal representative with respect to the probate of this estate a Final --Settlement was approved on June 25, 2024. However, as an inadvertent oversight on the part of the executor and personal representative because the same was not expressly a probate matter, the executor and personal representative mistakenly did not inform the County Commission at that time of the filing of the Final Settlement that the executor and personal representative had previously brought a wrongful death action on behalf of Amanda E. Fisher's statutory wrongful death beneficiaries, and that the executor and personal representative had been actively litigating that case. Although no further action was needed to be taken by the executor and personal representative with respect to the probate of this estate, Akira Jakkson's Letters of Authority needed to remain intact for the limited purposes of finalizing the wrongful death claims. The County Commission having been advised that a proposed settlement has been reached in the wrongful death action and that a hearing to approve the proposed settlement and distribution of settlement proceeds is scheduled to be conducted by the Honorable John D. Beene. Judge of the Circuit Court of Wood County, West Virginia on January 13, 2025, it is hereby ORDERED that Akira Jakkson's Letters of Authority as executor and personal representative of the Estate of Amanda E. Fisher shall be reinstated and shall remain intact for the purposes of finalizing the proposed settlement of the wrongful death claims or actions. It is further ORDERED that without further action needed to be taken by the County Commission, Akira Jakkson's Letters of Authority shall cease upon the entry of an appropriate order or orders from the Circuit Court of Wood County approving the proposed settlement and proposed distribution, and upon Akira Jakkson's completion of all tasks assigned to him by the Circuit Court regarding finalizing the settlement and distribution approved by the Circuit Court.
