MINUTES OF A REGULAR MONTHLY MEETING OF THE PUBLIC SERVICE BOARD OF THE MINERAL WELLS PUBLIC SERVICE DISTRICT HELD ON THURSDAY, MAY 18, 2000, IN THE DISTRICT'S OFFICE LOCATED AT MINERAL WELLS, WEST VIRGINIA

Mr. Charles Stewart, Chairman, called the meeting to order at 5:05 p.m. He asked everyone present to sign the attendance roster. Charles Stewart; Roy L. Radabaugh, Treasurer; James R. Lett, Secretary; Margaret Batten, Office Manager; Nellie Radcliff, Office Technician; Jerald D. Spears, Operations Manager; William Byers, Operations Technician; Denise Weppler, President of BDL Construction, Inc.; Dominick P. Cerrone, Assistant Engineer, Cerrone Associates, Inc.; Jim Mayles, Project Engineer, Cerrone Associates, Inc.; and Terry Bartley and Earl Roach, Residents; were in attendance.

Denise Weppler was in attendance to address the Board concerning the Board's motion made at the Special Meeting, May 17, 2000. Mr. Radabaugh explained that regrettably he could not make a motion to recind the motion that requested the Bid Bond be paid to the District. Mr. Lett agreed with Mr. Radabaugh. No motion was made on this request.

Terry Bartley was in attendance to ask the District to provide an additional 1,000 feet of pipe to extend the water line up to the top of the hill to Half-Acre. He stated that the District would pick up 4 more customers. Mr. Radabaugh made a motion to provide the pipe that Mr. Bartley requested, and that payment for such pipe should come out of the Sams Creek/ Chesterville Tap Fees funds. Mr. Stewart seconded the motion. The motion carried. Mr. Lett abstained from voting. Mr. Bartley excused himself from the rest of the meeting.

Mr. Mayles presented two Change Orders, one on Contract # 1 and one for Contract #2. As the Board and Mr. Mayles were discussing the orders an error was discovered in both orders. Mr. Mayles took the Change Orders back to his office to make the necessary corrections. Mr. Radabaugh made a motion that Mr. Stewart be authorized to sign the Change Orders once the corrections were made. Mr. Lett seconded the motion. The motion carried.

Mr. Mayles reported that Contract # 1 should be completed on or by June 1, 2000. Contract #2 will not be completed by June 1, 2000. The contractor still has about 2 ½ miles to complete Contract #2.

Mr. Mayles presented Requisition No. 8 for Mineral Wells Public Service District Water System Improvements on Contract # 1 in the amount of \$48,053.39. Mr. Radabaugh made a motion that Requisition No. 8 be approved and signed by Mr. Stewart as presented. Mr. Lett seconded the motion. The motion carried. Mr. Stewart signed the requisition.

Requisition No. 8 for the Mineral Wells Public Service District Rockport Waterline Extension project was presented by Mr. Mayles in the amount of \$59,484.28. Mr. Radabaugh made a motion

that Requisition No. 8 be approved and signed as presented. Mr. Lett seconded the motion. The motion carried. Mr. Stewart signed the requisition.

Dominick Cerrone, Assistant Engineer, presented the Board of Commissioners with a letter from Cerrone Associates, Inc. recommending Lou Morgan, the second low bidder, perform the work on the construction of the office/maintenance buildings. Lou Morgan Builders contract was in an amount of \$378,700.00. BDL Construction, Inc. had been awarded the bid on May 3, 2000, but they were unable to provide Performance and Payment Bonds.

Mr. Cerrone recommended to the Board that they give Notice of Award of the Bid for the Construction of the Office and Maintenance Buildings contingent upon:

- 1. Receiving confirmation from Lou Morgan Builders that it extends its Bid to cover the time needed by the District to give Notice of Award.
- 2. Concurrence from Gary Wilson from RUS of District's recommendation.

Mr. Radabaugh made a motion that Mr. Stewart be authorized to sign the Notice of Award once the final approval from Gary Wilson, Rural Utilities Service, is issued. Mr. Lett seconded the motion. The motion carried.

Mr. Lett made a motion the minutes of the April 20, 2000 Regular Board Meeting, May 8, 2000 Emergency Board Meeting, and May 17, 2000 Special Board Meeting be approved as written. Mr. Radabaugh seconded the motion. The motion carried.

Mr. Earl Roach addressed the Board. He reported that his property had been encroached upon again by the construction crew, but they had repaired his property to his satisfaction, except for one low spot at the upper end of his property. He said they had done a good job.

After reviewing the Financial Statements as presented, Mr. Radabaugh made a motion that the following items be approved.

Mr. Spears reported that he had a phone call from Gary Scott, Department of Highways, informing him that the District had lost the Federal Funding for the relocation of the lines at the Intersection State Rt. # 14 and I-77. He asked Jim Mayles to relay the message to Manning Frymier, Cerrone Associates, Inc. There was a brief discussion about how the District would replace the funds to relocate the lines, if the Federal Funds were indeed not available to the District.

Mr. Spears asked Mr. Mayles to inform Mr. James Ruckman, Professional Surveyor, for Cerrone Associates, Inc. that he needs to shoot the grade for the sewer in the Pettyville area. He reported that there is to be more growth in that area and that the sewer will need to expand. He would like for this to be completed as soon as possible.

All business having been completed, Mr. Radabaugh made a motion the meeting be adjourned. Mr. Lett seconded the motion. The motion carried. Mr. Stewart adjourned the meeting at 6:35 p.m.
