Mr. Charles Stewart, Chairman, called the meeting to order at 5:00 p.m. He asked everyone present to sign the attendance roster. Charles Stewart; Roy L. Radabaugh, Treasurer; James R. Lett, Secretary; Margaret Batten, Office Manager; Nellie Radcliff, Office Technician; Jerald D. Spears, Operations Manager; William Byers, Operations Technician; Mr. Manning Frymier, P. E., Cerrone Associates, Inc.; Mr. Terence C. Moran, P. E., Potesta & Associates, Inc.; Al Hammonds, Division of Highways; Dennis Affolter, Resident of Buck Run; David Affolter, Resident of Buck Run; and Earl Roach, Resident of Society Hill Road, were in attendance.

Mr. Al Hammonds and Mr. Terence Moran was in attendance to inquire if the District would be interested in the Division of Highways building and connecting a Sewer Lift Station and sewer lines from the I-77 Rest Area to the Districts' lines. They are willing to co-operate with the building and financing in any way that will be acceptable by the Board of Commissioners.

Mr. Radabaugh made a motion to co-operate with the Division of Highways to build a Waste Water Collection site and connect to the Districts sewer lines. Mr. Lett seconded the motion. The motion carried. Mr. Hammonds and Mr. Moran excused themselves from the rest of the meeting.

Dennis and David Affolter, Residents of Left Fork of Buck Run Road, was in attendance to inquire if there was going to be Contingency money to run water lines to their homes. Mr. Frymier presented a map that would include four (4) or five (5) more customers on Buck Run Road. After looking at the map, David Affolter discovered that the extension did not include his or Dennis Affolter's home.

Mr. Radabaugh made a motion that the District is willing to extend the line 4600 feet by Change Order to pick up four (4) or five (5) customers on the Left Fork of Buck Run Road. Mr. Lett seconded the motion. The motion carried.
