Secretary; Dominick P. Cerrone, P. E., Cerrone Associates, Inc.,: Jerald D. Spears, Operations Manager; Margaret Batten, Office Manager; Nellie Radcliff, Office Technician; Paul Kyer, Resident of Mineral Wells; Ted and Pam Casto, Peggy Hayes, Don Fordyce, and Douglas J. Holbert, Residents of Green Valley, were present to address the Board.

The first order of business addressed was Mr. Dominick Cerrone, P. E., Cerrone Associates, Inc., presenting a Change Order No. 9 for Contract 4 for the Water Systems Improvements Project in an amount of \$7,864,00. Mr. Radabaugh made a motion that Change Order No. 9 be accepted as presented. Mr. Lett seconded the motion. The motion passed. Mr. Stewart signed Change Order No. 9.

Mr. Cerrone presented Requisition No. 18 for Rockport Waterline Extension Project for an amount of \$55,814.70. Mr. Radabaugh made a motion that Requisition No. 18 for Rockport Waterline Extension Project be approved as presented. Mr. Lett seconded the motion. The motion passed. Mr. Stewart signed Requisition No. 18.

The next order of business discussed was with Paul Kyer, Resident of Scarce A Fat Road. He was very unhappy because he had to pay a minium water bill. He felt that he should not have to pay for water that he did not use. The Board informed him that the rules and rates were set by the Public Service Commission located in Charleston. Mrs. Batten gave Mr. Kyer a list of numbers for him to call. He was still unhappy, but dismissed himself from the rest of the Board meeting.

Ted and Pam Casto, Peggy Hayes, Don Fordyce, and Douglas J. Holbert were present to discuss the possibility of getting the District to help them get water lines to their property on Green Valley Road. Mr. Radabaugh and the rest of the Board informed them of the self-help rule and the possibilities of the Wood County Commission giving funds to help people in their situation. Mr. Casto, Mr. Radabaugh and Mr. Spears made plans to meet with the Wood County Commission on Monday, March 26, 2001 at 10:00 a.m. When the plans were confirmed about the meeting with the Wood County Commission, Ted and Pam Casto, Peggy Hayes, Don Fordyce and Douglas J. Holbert excused themselves from the rest of the Board meeting.

Mr. Lett made a motion to approve the Minutes of the February 15, 2001, Board Meeting. Mr. Radabuagh seconded the motion. The motion passed. Mr. Lett signed the Minutes.

There was no motion made for this item and it was tabled until a later time.

Mr. Spears. Operations Manager, reported that there were numerous items that he had to report on.

- 1. Tom Webster had been in contact with him concerning his working to sell, or develop vacant property, between Oakbrook and Lincolnshire, which contains 10 acres plus.
- 2. John Wilson, Jr. called him about building an apartment building (94'x26')in Windsor Estates - behind IGA.
- 3. Grace Gospel Church sewer lateral hasn't seen any action, problem needs resolved.
- 4. Al Hammonds, DOH, working to get agreement out on Sewer to I-77 Rest Areas - DOH is pressing to get done.
- 5. Materials for Mr. Affolter Buck Run Extension Project have been ordered and will be delivered Wednesday, March 21, 2001.
- 6. Sewer Line at Wal-Mart Extension has been completed to accommodate the new Ryans restaurant and others on the opposite side of roadway from Wal-Mart.
- 7. DOH is wanting the District to remove utilities from the Hunt and 2 Poling properties on State Rout 14. opposite Cracker Barrel. The District is working with Mr. Jesse Sheppard to get DOH to pay the cost of removing the grinder and etc.
- 8. Smoke Testing has been delayed because of weather. Eight hour composite Samples have been taken and analyzed by Lab. Samples have been taken in all cells of sewer ponds at Sewer Plant - lab tested and provided to Mr. Frymier, Cerrone Associates, Inc.
- Jim Ruckman, Cerrone Associates, Inc., will be here Tuesday, March 20, 2001, to go over Booster Station site on the Dent property. Columbia Gas will mark lines Friday or Monday on the site. As proposed, the site will not work.
- 10. De-chlorination upgrade is not underway as of this date.

Having discussed these items, Mr. Spears, also, mentioned some other items that are in the works. Slate Creek Bridge Project, Manhole issue at Deerfield Mobil Home Trailer Park and Mr. Frymier would like to start signing people up on the new waterline extension project.

Mr. Radabaugh made a motion that a pay raise of \$0.25 per hour be given to all employees retroactive to January 1, 2001. Mr. Lett seconded the motion. The motion passed.

The Commissioners asked for an Executive Session at 7:40 p.m.
