Mr. Radabaugh expressed his regret for the delay and stated the District was anxious to begin construction which hopefully would be in early spring.

Mr. Radabaugh made a motion to authorize Check Numbers 29989 thru 29997 written December 18, 2003 on the Sewer Revenue Fund Checking Account (copy attached). Mr. Lett seconded the motion. The motion passed unanimously.

Mr. Radabaugh made a motion to approve Payroll Check Number 001144 thru 01159 written between November 21, 2003 and December 18, 2003 on the Sewer Revenue Fund Checking Account (copy attached). Mr. Lett seconded the motion. The motion passed unanimously.

Mrs. Batten presented Requisition No. 2 in the amount of \$22,614.71 for the Dover Drive Dechlorination Project to the Board of Commissioners for approval. After reviewing the document, Mr. Radabaugh made a motion that Requisition No. 2 be approved for payment as presented. Mr. Lett seconded the motion. The motion passed unanimously. Mr. Stewart signed the requisition.

Mrs. Batten presented Requisition No. 5 in the amount of \$26,203.14 for the I-77 Rest Area Sewer Extension Project to the Board of Commissioners for approval. After reviewing the document, Mr. Radabaugh made a motion that Requisition No. 5 be approved as presented. Mr. Lett seconded the motion. The motion passed unanimously. Mr. Stewart signed the requisition.

Mrs. Batten presented the following letters:

Letter 44-Copy of letter dated December 12, 2003 to the Board Members of the Silverton Public Service District from the Jackson County Commission requesting that Silverton PSD contact the Mineral Wells PSD on behalf of the citizens of Cavin Fork and Pond Creek in Northern Jackson County and request that should they ever extend water service into their southern boundaries that they consider these areas of northern Jackson County.

Letter 56-Letter dated December 16, 2003 to Charles Stewart from Randall M. Cole, Cerrone Associates, Inc., enclosing for review and approval four (4) copies of Addendum No. 2 to the Engineering Agreement for the I-77 Rest Area Sewer Extension Project. After reviewing the document, Mr. Radabuagh made a motion that Addendum No. 2 be approved as presented. Mr. Lett seconded the motion. The motion passed unanimously. Mr. Stewart signed the Addendum.

Mr. Brabham gave his monthly operations report. The discussed the following items:

- 1. Contact #1-Dover Drive Sewer Replacement Project- The project is progressing rather slowly because of the weather and the condition of the soil. He stated that approximately 12% of the work had been completed and that 60% of the budget had been spent because of unexpected cost. Today, December 18, 2003, was to be the substantial completion date. Specialty Piping Corporation has asked Cerrone Associates, Inc. for a time extension to this Contract.
- 2. Contract #2-Treatment Plant-Work has not started as of this date.
- 3. Sycamore Run, Stephens Fork and Limestone Ridge Project-Mr. Brabham stated he had talked with Dianne Wolfe, Bowles Rice McDavid Graff & Love, and left a message but she had not yet returned his call. The Board authorized Mr. Brabham to call and set up a meeting with the Board, Mr. Hardman and Mrs. Wolfe at their office to discuss the remaining documents needed to get the project ready for the bidding process.
- 4. Sycamore Run, Stephens Fork and Limestone Ridge Project-Cerrone Associates, Inc. did survey work at the tank site last Friday, December 12, 2003.

Mr. Radabaugh made a motion the Board of Commissioners go into an executive session. Mr. Lett seconded the motion. The motion passed unanimously. Mr. Stewart recessed the regular meeting at 5:55 p.m.

At 6:35 p.m. Mr. Stewart reconvened the regular meeting and announced that no action was taken during the executive session.

Mr. Radabaugh announced that is was time for the Board to consider giving its employees a pay raise. A discussion ensued after which Mr. Radabaugh made a motion that each employee be given thirty-five (35) cent per hour increase effective January 1, 2004. Mr. Lett seconded the motion. The motion passed unanimously.

After discussion, Roy Radabaugh made a motion the office be closed at noon on Wednesday, December 24 and Wednesday, December 31, 2003 so that the employees can enjoy the holidays. Mr. Lett seconded the motion. The motion passed unanimously.

Mr. Radabaugh showed the Board an ad that appeared on behalf of the Red Sulphur Public Service District relative to a water extension project they were bidding. The ad was urging their residents who had not signed up and paid a tap fee for their project to do so before the construction started.

He suggested that our District should either run an ad or notify the people by letter who have declined water service for the Sycamore Run, Stephens Fork and Limestone Ridge project just before the bidding date.

All business having been completed, Mr. Radabaugh made a motion that the meeting be adjourned. Mr. Lett seconded the motion. The motion carried unanimously. Mr. Stewart adjourned the meeting at 6:45 p.m.
