- 6. WV Jobs Act Requirements WV Code 21-1C-1.

The Contracts will be as follows with the time of completion.

Contract No. 1- Sycamore Run, Stephens Fork, Rockcamp Run, Wolf Run/Slate Creek & Grassy Run Water Extensions - 180 Days time of completion.

Contract No. 2A - Limestone Area Water Extensions (West) - 200 days time of completion.
