Mrs. Batten presented Change Order No. 2 to Contract # 2A for the District's Sycamore Run Water Extension Project. This Change Order is for the addition of the restrained joint pipe that was needed on Line 43 due to the relocation of the line to avoid a slip. The amount of the Change Order is \$720.00 net increase. Mr. Radabaugh made a motion to approve Change Order No. 2 to Contract # 2 A. Mr. Lett seconded the motion. The motion passed unanimously.

Mrs. Batten discussed the following letters.

Letter 18 - Letter dated December 18, 2004, to Margaret Batten from Debbie Britt, Executive Director, West Virginia Rural Water Association, stating that the District's Voting Membership Dues for this year are due for renewal on February 1, 2005. The amount of the Dues are \$580.22. Mr. Radabaugh made a motion to approve the payment of dues. Mr. Lett seconded the motion. The motion passed unanimously.

Kappa, Director, Office of Emergency Services, containing a copy of the District's approved Project Application and a P.r Project Completion and Certification Report to be completed and submitted to the Office of Emergency Services for Project P.A. # 107-UOZ90-00, Fema-1558-DR-WV. This letter was postmarked January 18, 2005.

Letter 105 - Copy of a letter dated January 17, 2005, to Mr. Don Cottrill, United Welding, Inc., from Manning Frymier, P.E., Cerrone Associates, Inc., stating that he has forwarded Mr. Cottrill's request to reduce his retainage on Contract 2B of the Sycamore Run, Stephens Fork, Limestone Ridge Water Extension Project to the District for consideration.

Letter 108 - Fax dated January 17, 2005, to Shayne Brabham from Manning Frymier, P. E., Cerrone Associates, Inc., enclosing a copy of a letter dated January 14, 2005, to Mr. Frymier from Don Cottrill, United Welding, Inc., requesting that their retainage be reduced since the completion of their contract for the Sycamore Run, Stephens Fork, Limestone Ridge Water Extension Project is being held up by circumstances beyond their control. Mr. Radabaugh made a motion that is agreeable with the Board that the retainage be reduced to approximately \$50,000.00 if this is agreeable with Cerrone Associates, Inc., and Mr. Brabham, Operations Manager. Mr. Lett seconded the motion. The motion passed unanimously.

Mr. Brabham gave a brief report on the progress of the Water Extension Project. He reported that the Tie-in was completed today, January 20, 2005 at the south-bound I-77 Rest Area.

Mr. Brabham informed the Board that a slip has occurred on Sugar Camp Run Road that is causing a problem with the District's waterline. The waterline will have to be relocated. He has an estimate of a cost of \$2,800.00 for material only. There is no labor included in this quote.

There was a brief discussion concerning the Cutlip Warner Development project that is being developed on the Daugherty property. Mr. Brabham met with Jeff Bennett, Utility Inspector 11, Public Service Commission, concerning this project. Jeff recommended that the Ethics Commission be contacted because of the fact that Cutlip Warner is the contractor for the District. Mr. Brabham is to discuss the 5.5 Rule and the Alternate Agreement with Mr. Warner.

All business having been discussed, Mr. Radabaugh made a motion that the meeting be adjourned. Mr. Lett seconded the motion. Mr. Stewart adjourned the meeting at 6:00 p.m.
