Mr. Radabaugh made a motion to approve check number 31057 written April 21, 2005, on the Sewer Revenue Checking Account (copy attached). Mr. Lett seconded the motion. The motion passed unanimously.

Mr. Radabaugh made a motion to approve Payroll check number 1412 thru 1427 written on the Sewer Fund (copy attached) between March 17, 2005 - April 21, 2005. Mr. Lett seconded the motion. The motion passed unanimously.

The District had advertised a 1996 GMC Van to be auctioned off to the highest bidder at 5:30,but Gene Duckworth and his wife Crystal were the only ones present to place a bid. The Board decided to advertise the Van again and have another auction at the May 19, 2005, Board meeting. Gene and Crystal excused themselves from the rest of the meeting.

The only correspondence that Mrs. Batten had to discuss was Change Order No. 3 to Contract 4 to Panhandle Pipe/Hughes Supply for the District's Sycamore Run, Stephens Fork, Limestone Water Extension Project. This change order in the amount of \$2,200.00 is for the purchase of 4 Neptune Pocket Pro-readers. Mr. Radabaugh made a motion to accept Change Order No. 3 to Contract 4. Mr. Lett seconded the motion. The motion passed unanimously. Mr. Stewart signed Change Order No. 3 to Contract 4.

Mrs. Batten presented the Board with the new Water and Sewer Budget for the up coming year. She explained that due to the Sycamore Run, Stephens Fork, Limestone Ridge Water Extension Project that a projection of 60/40 perspective should be an accurate equation to determine the water/sewer shared expenses for July 2005-June 2006. With the expansion of the new project the District will be serving 2250 water customers and 1620 sewer customers. Mr. Radabaugh made a motion to accept the Water and Sewer Budget July 2005-June 2006 as presented. Mr. Lett seconded the motion. The motion passed unanimously.

Mr. Shayne Brabham submitted to the Board his Letter of Resignation to be effective May 13, 2005. Mr. Radabaugh made a motion to accept his letter of resignation effective at the close of the workday May 13, 2005. Mr. Lett seconded the motion. The motion passed unanimously.

Mrs. Batten requested permission to purchase another fire proof filing cabinet for a cost of \$1,549.00. Mr. Radabaugh made a motion authorizing the purchase of a fire proof filing cabinet. Mr. Lett seconded the motion. The motion passed unanimously.

Mr. Brabham reported to the Board on the progress of the Sycamore, Stephens Fork, Limestone Water Extension Project. Sampling on Contract 2B has been done. The Contractor has done some improvements to the Dent property where the booster station was installed, but there are still issues that need to be taken care of.

Lionel Thomas - Gates Ridge- has decided they cannot afford to install the service line from where the district would set their meter, therefore, that extension has been canceled.

Virginia McDonald gave the District a verbal approval to purchase the Radio Read meters for the water extension project. The District will start setting meters the first of next week.

A mud slide took out a sewer service line on Sam's Creek Road. The district has installed a jumper line to take care of the customer until the Department of Highways can get the slip removed. It has been turned over to their slip engineer.

The district has sent a letter to the Department of Highways in reference to the slip at the "VIP" Club. The District has a 3" sewer line in the ditch line and a 2" line going up the hill to the Criss resident on top of hill.

Mr. Radabaugh made a motion to go into an executive session at 6:50 p.m. Mr. Lett seconded the motion. The motion passed unanimously.

The meeting reconvened at 7:15 p.m. with no motions being made while in executive session.

Mr. Radabaugh made a motion to accept Russell Hanna's application for Operations Manager effective 4/25/05. His rate of pay is to increase \$1.50 per hour while he is in training. At the time he takes over as Operations Manager his pay is to increase to \$16.80. Mr. Lett seconded the motion. The motion passed unanimously.

All business having been discussed, Mr. Radabaugh made a motion that the meeting be adjourned. Mr. Lett seconded the motion. The motion passed unanimously. Mr. Stewart adjourned the meeting at 8:00 p.m.
