MINUTES OF A REGULAR MONTHLY BOARD MEETING OF THE PUBLIC SERVICE DISTRICT BOARD OF THE MINERAL WELLS PUBLIC SERVICE DISTRICT HELD THURSDAY, SEPTEMBER 15, 2005 AT 5:00 P.M. IN THE DISTRICT'S OFFICE LOCATED AT MINERAL WELLS, WEST VIRGINIA

Mr. Charles Stewart, Chairman, called the meeting to order at 5:00 p.m. He asked everyone present to sign the attendance roster. James R. Lett, Secretary; Roy L. Radabaugh, Treasurer; Russell Hanna, Operations Manager; Randy Harris; Pat Mc Clung; Dave Gorrell; Beth Bumgarner, Harmon Thompson, A.C; James Ice, Harmon Thompson, A.C; Cathy Dyer, Office Clerk; Linda Church, Office Manager; Jim Dickel; Nellie Radcliff, Office Clerk; Blaine Radcliff; William Byers, Operations Technician were present

The first order of business was the presentation of the annual audit report by Ms. Bumgarner, CPA, with the firm of Harman Thompson, A.C. She reported that the firm had audited the financial statements of the District for the year ended June 30, 2005 and issued a report dated August 26, 2005. In planning and performing the audit, Mineral Wells Public Service District's internal control over financial reporting was in order. There was no significant difficulties in dealing with management in performing and completing the audit. The audit was a good clean audit. After a brief discussion Ms. Bumgarner and Mr. Ice excused themselves from the rest of the meeting.

Randy Harris, Pat McClung, Dave Gorrell, Jim Dickel, and Blaine Radcliff were present to participate in an auction of a walk-behind gravely mower at 5:30 p.m. Mr. Radabaugh started the bidding at 5:30 with Dave Gorrell having the final bid of \$575.00. Mr. Radabaugh made a motion to accept the bid of \$575.00 for the Gravely Walk-Behind Mower. Mr. Lett seconded the motion. The motion passed unanimously. Randy Harris, Pat McClung, Dave Gorrell, Jim Dickel and Blaine Radcliff excused themselves from the rest of the meeting.

The District had been approached by the Public Service Commission concerning billing and/or termination of sewer customer for K.G. Anderson's subdivision located on Butcher Bend Road. The customers of the subdivision are served by Mr. Anderson's private sewage lagoon that does not meet the quality standards. After a brief discussion Mr. Radabaugh made a motion that the District had no interest in billing and collecting sewer revenue or terminating water service to collect delinquent sewer accounts for the K. G. Anderson subdivision. Mr. Lett seconded the motion. The motion passed unanimously.

Linda Church, Office Manager, presented the water purchase agreement for Claywood Park PSD's new water treatment plant project. After a discussion, Mr. Radabaugh made a motion to accept the new water purchase agreement (copy attached). Mr. Lett seconded the motion. The motion passed unanimously. Mr. Stewart signed the new water purchase agreement.

Mr. Lett made a motion to approve the Minutes of the August 18, 2005, Regular Board Meeting as

Mr. Radabaugh made a motion to approve payroll check numbers 1559-1577 written on the Consolidate Payroll Account (copy attached) between August 19, 2005 - September 15, 2005. Mr. Lett seconded the motion. The motion passed unanimously.

Mrs. Church discussed the following letters of correspondence with the Board.

Letter 16- Letter postmarked August 18, 2005, from Harlan L. Lott to the Mineral Wells Public Service District inquiring about the District's authority to place a waterline across his property. Asking for waterline to be removed, property restored to its original condition and a public apology.

Letter 25 - Letter dated August 24, 2005, from James Ruckman, PS Director of Field Activities, Cerrone Associates, Inc., to Russ Hanna enclosing easement and tax maps on the Harlan Lott trespassing letter per his conversation with Russ on August 23, 2005.

He had been in contact with Mr. Harlan Lott in reference to the letter we received. The Board authorized Mr. Hanna to contact Cerrone, Inc., the engineering firm to get their in-put concerning the fact that a 2" water main line was installed on property for which an easement had not been obtained. The Board will wait to hear from them.

Some of the items that were discussed at the meeting of the West Virginia Rural Water Association Mr. Hanna attended at the Canaan Valley Conference in September were collection agencies collecting charge off accounts, cost of materials to do road bores being the responsibility of the customer with the district bearing only the cost of the casing for a bore.

Mr. Hanna discussed with the Board the fact that the District could buy approximately 33 meters out of the contingency money from the project.

Mr. Lett brought it to the Boards attention that the men in the maintenance department would like to drive the service truck home the week that they are on call. The Board said they would take this under advisement. No motion was made on this item.

Mr. Radabaugh made a motion to resend the motion that had been made and approved at the Special Board Meeting of September 9, 2005 asking for a Class Cost of Service Study to be conducted by the Public Service Commission after the new water treatment plant has been in service for one year if requested by either party. Mr. Lett seconded the motion. The motion passed unanimously.

All business having been discussed, Mr. Lett made a motion the meeting be adjourned. Mr. Radabaugh seconded the motion. Mr. Stewart adjourned the meeting at 7:25 p.m.
