The first order of business was the reading and approving of the Minutes of the October 20, 2005, Regular Board Meeting. Mr. Lett made a motion to approve the Minutes of the October 20, 2005, Regular Board Meeting as presented. Mr. Radabaugh seconded the motion. The motion passed unanimously.

Letter 35 - Fax dated November 3, 2005, to Russ Hanna from Manning Frymier, PE Cerrone Associates, Inc. informing the Mineral Wells PSD of being qualified to paint the Mineral Wells Hill Tank "A" from funds of the Stephens Fork, Limestone Extension Project.

Letter 49 - Letter received November 10, 2005, to Sandra Squire, Public Service Commission of WestVirginia, from Todd Grinstead, General Manager, Claywood Park Public Service District, Case No 05-0479 - PWD-CN-PC that Claywood PSD file a 19A application requesting a class cost of service study be performed. The letter request that the Order be amended to read exactly the same as the executed agreement between Claywood PSD and Mineral Wells PSD. Mr. Radabaugh made a motion that the District write a letter to Sandra Squire, Public Service Commission of West Virginia stating that the Order be re-written to read exactly as the executed agreement between Claywood PSD and Mineral Wells PSD. Mr. Lett seconded the motion. The motion passed unanimously.

Letter 54 - Letter received November 15, 2005, to Russ Hanna from Steven Hardman, Bowles Rice McDavid Graff and Love LLP, attaching memorandum notes on the Harlan Lott property.

Letter 69 - Fax received November 17, 2005, to Linda Church from Walter Frazier, Appalachian Software, Inc., enclosing cost information for the ASI payroll system. Mr. Radabaugh made a motion authorizing Linda Church to purchase the payroll system from ASI. Mr. Lett seconded the motion. The motion passed unanimously.

The District was notified by WesBanco that the Grinder Pump account has been inactive for a period of (2) Two years and that a deposit should be made to keep the account active. Mr. Radabaugh made a motion for Mrs. Church to transfer \$2,000.00 into the Grinder Pump Account. Mr. Lett seconded the motion. The motion passed unanimously.

This concluded Mrs. Church's report.

Mr. Hanna reported on the following items.

Sludge is to the point that it has to be removed from the Waste Water Treatment Pond # 1. The District has contacted IVS concerning this, and they have a new method of sludge removal called the bag system which they will be using. This will have to be put up for bid because the total cost

of sludge removal will be more than \$15,000.00. The cost is approximately \$75,000.00 -\$80,000.00.

The District got the approval to paint the Mineral Wells Hill Water Storage Tank with Contingency Funds left over from the Sycamore, Stephens Fork, Limestone Ridge Water Extension Project. Bogal Ridge Water Storage Tank is still in question as to whether the District will be allowed to paint it with funds from the project. Mr. Frymier, P. E. Cerrone, Inc., is working on getting approval from Rural Utilities

The Harlan Lott problem is still being handled by the District's lawyer. There has been no decision made concerning this right-of-way issue.

Leigh Mason Trailer park is in the final stages. The District's cost of a road bore will be approximately \$4,800.00

All business having been discussed, Mr. Lett made a motion the meeting be adjourned. Mr. Radabaugh seconded the motion. The motion passed unanimously. Mr. Stewart adjourned the meeting at 6:30 p.m.
