Mr. Charles Stewart, Chairman, called the meeting to order at 5:00 p.m. He asked everyone present to sign the attendance roster. Roy L. Radabaugh, Treasurer; James R. Lett, Secretary, Nellie Radcliff, Office Clerk, Brian Metz, Operations Technician; Linda K. Church, Office Manager; William Byers, Operations Technician and Russell Hanna, Operations Manager, were present.

The first order of business was the reading of the Minutes of the April 20, 2006, Regular Board Meeting. Mr. Lett made a motion to approve the Minutes as presented. Mr. Radabaugh seconded the motion. The motion passed unanimously. Mr. Lett signed the Minutes.

Mrs. Church presented the proposal from the firm of Harman Thompson A.C. to perform the District's annual audit for Fiscal Year 2006. The amount of the proposal was \$9,200.00. Mr. Radabaugh made a motion to accept the proposal as stated. Mr. Lett seconded the motion. The motion passed unanimously.

Mrs. Church presented the Board with a list of Charge Offs for the Fiscal Year 2006. The total Charge Offs for the Fisca'l Year 2006 is \$4,573.47 (see list attached). The total for water is \$2,502.41. The total for sewer is \$2,071.06. Mr. Radabaugh made a motion to approve the total amount of Charge Offs for Fiscal Year 2006. Mr. Lett seconded the motion. The motion passed unanimously.

Mrs. Church presented the Requisition No. 19 for the Sycamore Run, Stephens Fork Water Extension Project for approval. The amount of this requisition was \$8,514.56. Mr. Radabaugh made a motion to approve Requisition No. 19 as presented. Mr. Lett seconded the motion. The motion passed unanimously. Mr. Stewart signed Requisition 19.

Mr. Radabaugh made a motion to approve the Financial Statement dated April 30, 2006, for All Finances (copy attached). Mr. Lett seconded the motion. The motion passed unanimously.

Mrs. Church reported that because of the cash flow in Water Revenue Fund Checking Account being so close, the District may need to consider a rate increase. There was a brief discussion regarding a rate increase, but no motion was made. This concluded Mrs. Chruch's report.

Mr. Hanna discussed the following items with the Board.

Item #1 - Bogal Ridge Water Extension information has been put together, but the lady that was to be at this board meeting called and canceled.

Item #2 - Loraine Bartlett water line extension is progressing. Ms. Bartlett brought in payments from the potential customers.

Item #3 - Gene Duckworth's line extension is being installed. He is doing his work.

Item #4 - Progress has been very slow at the Wastewater Treatment Plant regarding the sludge removal.

Item #5 - The bill for the Security System may need to be looked at to see if it can be trimmed down in order to save the District money.

This concluded Mr. Hanna's report. There was a brief discussion on each of the items, but no motions were made.

All business having been discussed, Mr. Lett made a motion the meeting be adjourned. Mr. Radabaugh seconded the motion. The motion passed unanimously. Mr. Stewart adjourned the meeting at 7:30 p.m.
