They also recommended changes to our tariff, those including the Reconnect Fee be changed from \$20.00 to \$25.00, Water & Sewer Tap Fees from \$300.00 to \$350.00 and a Returned check fee of \$25.00 (only if our Financial Institution would ever charge us).

Mrs. Dyer had nothing further to discuss.

Mr. Anderson reported to the board that he had a phone call from Donna Florence in regards to us providing sewer to property on Lost Pavement Road that will be sold. Mr. Anderson informed her that they would need two (2) Grinders and would need to do two (2) Road punches. The Board stated to Mr. Anderson that we would pay for the 1st road punch, the second and all other expenses would be theirs to pay; and of course all proper easements would need to be signed.

Mr. Anderson had nothing further to discuss.

Mr. Lett seconded the motion. The motion passed unanimously.

All business being discussed, Mr. Lett made a motion to adjourn. Mr. Radabaugh seconded the motion. The motion passed unanimously. Mr. Stewart adjourned the meeting at 2:15 p.m.
