Mr. Lett made a motion to start the procurement process for the Pond Creek Water Line Extension as discussed with the Board. Mr. Stewart seconded the motion. The motion passed unanimously.

Mrs. Dyer presented the Board with an invoice for \$1,000.00 for legal fees from Stuttle & Stalnaker for the 2009 Miscellaneous Water Improvement Project. Mr. Lett made a motion to approve the invoice as presented. Mr. Stewart seconded the motion. The motion passed unanimously.

Mr. Lett made a motion to approve the tariff change effective with substantial completion of the Miscellaneous Water Improvement Project. Mr. Stewart seconded the motion. The motion passed unanimously.

Mr. Lett made a motion to approve the final plans for the relocation of the Districts water and sewer lines received from the WV Department of Highways State Route 14 South Interchange plans per the recommendation of Manning Frymier, P. E. Cerrone Associates, Inc., engineering firm. Mr. Stewart seconded the motion. The motion passed unanimously.

Mr. Lett made a motion to approve a one time only pay increase of \$150.00 per employee. Mr. Stewart seconded the motion. The motion passed unanimously.

Mr. Anderson discussed with the Board his concerns of needing three phase electric wiring for all of the District's Booster stations, especially the Slate Booster because of the work that will be done at the Bogal Ridge Tank site. It is the consensus of the Board that all of the Boosters should be wired to accept a portable generator in case of power failure over an extended period of time. The quotes for the Boosters came in as follows: Slate Creek Booster, \$4,703.00 - Saulsbury, \$5,160.00 -
