The purpose of this Board Meeting being held today February 25, 2010, is that on February 18, 2010, the meeting had to be postponed due to not having a quorum to make and approve motions.

The Board did not elect a new treasurer at this meeting.

There was no one from the public present.

There was no one present from the Pond Creek area to discuss the waterline extension.

Mr. Lett made a motion to approve the Minutes of the January 21, 2010, Regular Board Meeting as presented. Mr. Radabaugh seconded the motion. The motion passed unanimously. Mr. Lett signed the Minutes of the Regular Board Meeting.

Mr. Lett made a motion to approve the Minutes of the February 2, 2010, Special Board Meeting as presented. Mr. Radabaugh seconded the motion. The motion passed unanimously. Mr. Lett signed the Minutes of the Special Board Meeting.

Mrs. Dyer presented the Board with the scores for the selection of engineering firms (see attachment). The engineering firm with the highest score was Cerrone Associates, Inc. Mr. Lett made a motion to approve Cerrone Associates, Inc., as the engineering firm for the Water System Extension and Improvement Project. Mr. Radabaugh seconded the motion. The motion passed unanimously.

Mrs. Dyer presented the Board with Requisition No. 3 in the amount of \$66,228.93 for the Miscellaneous Water Improvement Project. Mr. Lett made a motion to approve Requisition No. 3. Mr. Radabaugh seconded the motion. The motion passed unanimously. Mr. Radabaugh signed Requisition No. 3.

Mrs. Dyer presented the Board with Change Order No. 4 - Mid-Atlantic Storage Systems for the relocation of the Bogal Ridge PRV on the Miscellaneous Water Improvement Project. The change order was a request to extend the completion time of the project to March 25, 2010. Mr. Lett made a motion to approve Change Order No. 4 as presented. Mr. Radabaugh seconded the motion. The motion passed unanimously. Mr. Radabaugh signed Change Order No. 4.

Mrs. Dyer presented the Board with Addendum No. 1 to the Engineering Agreement for the Miscellaneous Water Improvement Project. Mr. Lett made a motion to approve Addendum No. 1 to the Miscellaneous Water Improvements Project as presented. Mr. Radabaugh seconded the motion. The motion passed unanimously. Mr. Radabaugh signed Addendum No. 1.

Mrs. Dyer presented the Board with a Letter of Engagement from Suttle & Stalnaker for the 2010 Water and Sewer Audit in the amount of \$11,200.00. Mr. Lett made a motion to approve the Letter of Engagement from Suttle & Stalnaker. Mr. Radabaugh seconded the motion. The motion passed unanimously. Mr. Radabaugh signed the Letter of Engagement.

Mrs. Dyer presented the Board an invoice from Trimble & Associates in the amount of \$1,125.00, for preparing the District's arbitrage reports and opinion letters. Mr. Lett made a motion to approve the invoice

Mrs. Dyer discussed with the Board that Municipal Bond Commission would very much like for the District to make the Districts payments electronically. The payments will be made by the District when funds are available and not automatically deducted from the District's bank account. Mr. Lett made a motion to approve the electronic payments as discussed. Mr. Radabaugh seconded the motion. The motion passed unanimously. Mr. Radabaugh signed the electronic resolution.

Mr. Lett made a motion to approve the Financial Statement dated January 31, 2010, for All Finances (copy attached). Mr. Radabaugh seconded the motion. The motion passed unanimously.

Mr. Lett made a motion to approve the Financial Statement dated January 31, 2010, for Water Revenue Fund Checking Account (copy attached). Mr. Radabaugh seconded the motion. The motion passed unanimously.

Mr. Lett made a motion to approve the Financial Statement dated January 31, 2010, for Sewer Revenue Fund Checking Account (copy attached). Mr. Radabaugh seconded the motion. The motion passed unanimously.

Mr. Lett made a motion to approve checks 40426 thru 40612 written on the Consolidated Water and Sewer Revenue Checking Account between January 22, 2010 and February 18, 2010, (copy attached). Mr. Radabaugh seconded the motion. The motion passed unanimously.

Mr. Lett made a motion to approve Payroll Checks 2665 thru 2704 written on the Consolidated Payroll Account between January 22, 2010 thru February 18, 2010, (copy attached). Mr. Radabaugh seconded the motion. The motion passed unanimously.

The following items were discussed with the Board.

Letter #2 - Letter dates January 21, 2010 from Anne Lambright, Executive Director for the Public Employees Retirement System effective July 1, 2010, the Employer contribution will be increased from 11% to 17%.

Letter #8 - Letter dated January 21, 2010, from Municipal Bond Council reference the new loan amount for the refinanced 1997 loan is now \$7,865.03, a savings of \$1,174.97 per month. The Reserve Fund for the new loan is fully funded @ \$94,3880.00 (one year loan payments).

Letter #9 - Letter from RUS the signed Request for Obligation of Funds for the Sewer Improvements Project.

Letter #91 - Letter dated February 9, 2010, to Rep. Alan Mollohan attached project proposal for funding of the Miscellaneous Water Line Extension Project.

Mrs. Dyer presented the Board with a quote from H. D. Waterworks for \$6,985.00 for a new meter reading handheld.

The Districts 30 B Case is now before the ALJ and Claywood Public Service District rate increase for the Cost of Class Survey may become effective May 28, 2010.

Mrs. Dyer informed the Board that the Office had received conformation that Mark Stewart had been approved for the commissioners office of Treasurer from which Mr. Charles Stewart had resigned effective January 31, 2010.

This concluded Mrs. Dyers report.

Mr. Anderson reported that rewiring parts for the Limestone, Saulsbury, Slate and Bonnevale booster station have been ordered. The new Mineral Wells Hill Tank has been cleaned and some water has been put in it. Larry (Mid Atlantic) wants to go ahead and fill the tank, but the District feels that tests results should be back before final filling. The Board agrees that this is the correct method to follow because of the cost of water to fill the tank, then if tests results are bad this water would be a great loss to the District. This concluded Mr. Anderson's report.

All business having been discussed, Mr. Lett made a motion that the meeting be adjourned. Mr. Radabaugh seconded the motion. The motion passed unanimously. Mr. Radabaugh adjourned the meeting at 5:30 p.m.
