MINUTES OF A REGULAR MONTHLY BOARD MEETING OF THE MINERAL WELLS PUBLIC SERVICE DISTRICT HELD AUGUST 19, 2010, AT 5:00 P.M. IN THE DISTRICT'S OFFICE LOCATED AT MINERAL WELLS, WEST VIRGINIA

Mr. Radabaugh, Chairman, called the meeting to order at 5:00 p.m. He asked everyone present to sign the attendance roster. Stephen R. Varner, Sr., resident of Mineral Wells; Cathy Dyer, Office Manager; Nellie Radcliff, Office Clerk; Mark D. Stewart, Treasurer; James R. Lett, Secretary; Todd Anderson, Operations Manager; and Virginia Donaldson, resident of Pond Creek, were present.

The first order of business was the discussion with Mr. Varner wanting to know if the District would allow him to obtain an easement from a neighbor of his to set his own meter to haul water to his resident. He lives in an area that will probably never have water service. After a brief discussion the Board agreed that if a neighbor would agree to give the District and Mr. Varner an easement the District would provide the water. Mr. Varner is to get back with the District with an answer. He excused himself from the rest of the meeting.

Mr. Lett made a motion to approve the Minutes of the July 15, 2010, Regular Board Meeting as presented. Mr. Stewart seconded the motion. The motion passed unanimously. Mr. Lett signed the Minutes of the July 15, 2010, Board Meeting.

Mrs. Donaldson was present to thank the Board for having the meeting and signing user agreements in regards to the Pond Creek Waterline Extension. The Board is hoping for a grant to fund the extension. If the grant is not obtained, the District cannot afford to put the water in the Pond Creek area. Mrs. Donaldson excused herself from the rest of the meeting.

Mr. Lett made a motion to approve the opening of a Bank Account for the Pond Creek Waterline Extension. Mr. Stewart seconded the motion. The motion passed unanimously. Mr. Radabaugh, Mr. Lett, Mr. Stewart and Mrs. Dyer signed signature cards for the new account.

Mr. Lett made a motion to approve Cerrone Associates, Inc., to apply for a Rule 42 for a Water rate increase. Mr. Stewart seconded the motion. The motion passed unanimously.

Mr. Lett made a motion to approve Cerrone Associates, Inc., to apply for a Rule 42 for a Sewer rate increase. Mr. Stewart seconded the motion. The motion passed unanimously.

Mr. Stewart made a motion to approve the Financial Statements of All Finances, Water Revenue Checking Account, Sewer Revenue Checking Account as presented (copy attached). Mr. Lett seconded the motion. The motion passed unanimously.

Mr. Stewart made a motion to approve checks #41002 thru #41087 written on the Consolidated Water and Sewer Revenue Checking Account (copy attached) between July 15, 2010 and August 19, 2010. Mr. Lett seconded the motion. The motion passed unanimously.

Mr. Stewart made a motion to approve Payroll Checks #2873 thru #2912 written on the Consolidated Payroll Account (copy attached). Mr. Lett seconded the motion. The motion passed unanimously.

Mrs. Dyer discussed the following correspondence with the Board.

Letter #38 - Copy of a letter and application for the Pre-Construction Expense Assistance to the WV Infrastructure for the Sewer System Improvement Project.

Letter #59 - Letter dated July 28, 2010, from Joseph Hickman of the West Virginia DEP attaching (2) non-compliance items from the Waste Water Treatment Plant inspection on July 8, 2010.

Letter #73 - Copy of a Letter dated August 5, 2010, to Scott Mandirola, Director of the WVDEP responding to the non-compliance items.

Letter #85-#87-Letters dated August 9, 2010, from Gregory Dugan, Executive Director, WesBanco effective September 10, 2010, the WesBanco Prime Rate on Balances of \$100,000.00 or more are being restructured and the interest rate will be at their discretion. The current rate is 1.3%. The accounts that will be effected are Sycamore Repair and Replacement, Sewer Repair and Replacement and the Grinder Pump Repair.

Letter #98 - Copy of letter dated August 12, 2010, to Sandra Squire, PSC, from Terry Owen, PSC answer from request to reopen case # 09-0147-PWD-CN for a tariff change request for the final disposition approval to be expedited.

Mrs. Dyer discussed with the Board the purchasing of new computers thru Rural Development. Alan Harris, Rural Development, explained to Mrs. Dyer what she needed to do in order to make the purchase thru Rural Development. There will be some money left in the Miscellaneous Water Extension Project, to buy meters.

Mr. Anderson reported that the West Virginia Labors Training Center had purchased the land next to their property and would like for the District to allow them at their expense to move the the 4" waterline. The training center would like to up grade the 4" line to a 6" line. The District feels that it would agree to this idea. The District would pay the difference from a 4" to a 6" and install a fire hydrant. There needs to be an agreement between the District and the Training Center for these improvements. The District's lawyer will need to see the agreement and approve it.

Because of the recurring problems the District has been having at the Wastewater Treatment Plant, Mr. Anderson, Denny Brown and Bill Byers went to Parsons to tour their facility. The Blower Building was very quite. Mr. Harper recommended that each pond has its own blower.

The Dept. of Highway project may soon be starting.

The meeting with the lawyers and Ms. Hill over the Anderson Lagoon went well. The District informed them that it did not want all the problems that it would incur. Ms. Hill said there was no sense in taking up anymore of the lawyers time or hers.

The meeting at the Pond Creek Fire Station went well. There were several people interested in getting water. There needs to be several more people interested before the project will be able to obtain funding.

All business having been discussed, Mr. Lett made a motion the meeting be adjourned. Mr. Stewart seconded the motion. The motion passed unanimously. Mr. Radabaugh adjourned the meeting at 6:45 p.m.
