Mr. Stewart made a motion to approve checks written on the Consolidated Water and Sewer Revenue Checking Account for November 30 and December 31, 2020. Mr. Cothern seconded the motion. The motion passed unanimously.

Mr. Stewart made a motion to approve Payroll Checks written on the Consolidated Payroll Account between November 2020, December 2020. Mr. Cothern seconded the motion. The motion passed unanimously.
