MINUTES OF A REGULAR BOARD MEETING OF THE PUBLIC SERVICE BOARD OF THE MINERAL WELLS PUBLIC SERVICE DISTRICT HELD THURSDAY, August 18, 2022 AT 2:00 P.M. IN THE DISTRICT'S OFFICE LOCATED AT MINERAL WELLS, WEST VIRGINIA

Mr. Roy Radabaugh, Chairman called the meeting to order at 2:00 PM. He asked everyone present to sign the attendance roster. Luke Peters discussed Draw down #21 for Sewer Project. Requested an additional \$1,000 sent to WesBanco and ask if WesBanco could take the interest payment directly out of the account. The contract for Change Order #1, bypass pumping, was extended for 60 days for a total cost of \$67,228.42.

Mike Davis discussed the Wastewater Project was lacking signed easements. He also discussed resurveying 3 locations.

Mr. Cothern made a motion to approve Item #6, Mr. Stewart seconded the motion and it passed unanimously.

Mr. Cothern made a motion to approve Drawdown #21, Mr. Stewart seconded the motion and it passed unanimously.

Mr. Cothern made a motion to approve Amendment #4, Mr. Stewart seconded the motion, and it passed unanimously.

Luke Peters discussed the reduction in cost for Draw Down #7. Mr. Stewart made a motion to approve Draw Down #7, Mr. Cothern seconded the motion and it passed unanimously.

Mr. Stewart made a motion to approve item number 7.8 & 9, Mr. Cothern seconded the motion and it passed unanimously.

Mr. Anderson talked about Rt. 21 having a leaking valve and it was repaired DV Weber under warranty. All inventory has been accounted for for 2022. Mr. Anderson also discussed the repairs needed for Bill's old truck.

The Board moved to executive session.

No motions were made during executive session.

All business having been discussed, Mr. Cothern made a motion to adjourn. Mr. Radabaugh seconded the motion. The motion passed unanimously. Mr. Radabaugh adjourned the meeting at 3:25 P.M.
