Mr. Roy Radabaugh, Chairman called the meeting to order at 2:00 PM. He asked everyone present to sign the attendance roster. Mr. Siegrist spoke about the audits and the need for them to be completed by March 29th of each year going forward. Mr. Siegrist also asked for approval from the Board for the extension of the Bond Anticipation Note.

Mr. Stewart made a motion to approve the Bond Anticipation Note. Mr. Cothern seconded the motion. The motion passed unanimously.

Mike Davis spoke about the Lagoon levels that needed to be sent to the DEP. He will have a presentation at the next Board Meeting on July 20, 2023.

Mr. Stewart made a motion to approve items 6, 7 & 8. Mr. Cothern seconded the motion and in passed unanimously.

General Manager- Todd Anderson spoke to Steve Hardman about needing the signature from the Boise family for an easement. Mr. Anderson also brought up the need to review the amount the District pays toward employees health insurance. Mr. Radabaugh asked us to gather information from other Districts showing the amounts they pay toward employee health insurance. He would like this information for the next Board Meeting on July 20, 2023.

Mr. Stewart made a motion to adjourn the meeting at 3:00pm. Mr. Cothern seconded the motion. The motion passed unanimously.
