Todd also talked about the Windy Tank survey. We are ready to meet with the Boice's. Lantz and Smith easements will be condemnations. Mr. Anderson also discussed the need for 2 new trucks for the PSD. He will be collecting quotes from local dealerships. BRIM will cover \$10,980.00 minus \$2,500.00 deductable to repair the roof at the WWTP. The total cost will be \$21,960.00 and we have to cover half of the total.

Mr. Stewart made a motion to approve items 5, 6 and 7. Mr. Cothern seconded the motion and in passed unanimously.
