H. E. Seufer called the meeting to order.

Read minutes of regular board meeting from May 21, 2003. R. J. Mullenix moved to accept minutes. H. W. Sweeney second. Unanimous.

H. W. Sweeney moved to accept the financial reports for May 31, 2003. R. J. Mullenix second. Unanimous.

Discussed Wastewater Project. Dominick provided an updated schedule. Discussed Granada Hills and the lack of response from Mr. Wilhelm to sign necessary documents. R. J. Mullenix made a motion to change Granada Hills to a bulk customer if the responsible parties refused to negotiate with the District before the loan closing. H. W. Sweeney second. Unanimous. Discussed right-of-ways. Jonathan Carpenter provided an update. Discussed the lift station site needed from L & M Development. They have made a counter offer of \$13,000, siting a negotiation with WVDOH as justification for the cost. They denied a request to provided the details of their justification. H. E. Seufer recommended obtaining appraisals for the L & M site and the Role, Inc. site. Condemnation proceedings for right-of-ways and property that are unobtainable through negotiation need to be carried out by early September in order to meet project deadlines. Discussed Robert Keltner's rightof-way and plans for his property. He has described future plans for a motel, a restraunt, and a service station at this site. Being a pressure system it is not possible for the district to construct a system large enough to satisfy his future plans, yet provide adequate service before those plans are recognized. Mr. Keltner told Jerry Dotson that he has discussed this situation with Williamstown, and said that Williamstown will provide service. Jerry Dotson will contact Williamstown to confirm this, and discuss removing this property from the project for Williamstown to provide service at a
