Read minutes of regular board meeting from June 8, 2005 and special board meeting July 12, 2005.

R. J. Mullenix moved to accept minutes. S. L. Nulter second. Unanimous.

S. L. Nulter moved to accept the financial reports for June 30, 2005. R. J. Mullenix second. Unanimous.

Discussed Wastewater Project. Several customers attended to discuss concerns with their property where the contractor has either failed to properly restore the property or has done some sort of damages. John Bailey, Bob and Kathy Kimble, Mark Riel, Lynn Staton, Barbara Hickman, Kenneth Watson, James and Barbara Bolinger, and John Ash were heard. Dwight Brookover is out of town, but provided copies of letters for the board to consider. Jim Sharp was on the agenda but not present. The board discussed some issues that were repeatedly brought up in the complaints.

Jim Mayles provided an update. On Contract #3, substantial completion for the gravity system and 16" forced main was established on July 12, 2005. The remaining pressure mains are estimated to be ready for substantial completion on August 2, 2005. Contract #2 is estimated to be ready for substantial completion next week.

Jonathan provided an inspection update. From May 31 to July 9 inspection ran \$32,000. An additional \$16-20,000 cost is expected to reach early August. Once the line testing is completed, inspection staffing can be reduced.

Discussed final adjusting change orders. Jim Mayles had change orders for the boards approval, however, the WVDEP has not reviewed the change orders so no action was taken. Jim Mayles provided a project contingency update. Mr. Seufer expressed concern that Dominick said at the last meeting the there was a quantity overrun issue on Contracts #2 & 3 that needs reviewed. Kathy Emery explained that overpaying a contractor with SRF money is a violation of the loan agreement. If there are overruns that have already been paid, then the District should not authorize any more payments to that contractor until the quantities are reconciled. Jim Mayles provided Pay Requisition #18. S. L. Nulter moved to pay the amounts requested for Contract #1, Cerrone Associates, Union Williams PSD, and Thrasher Engineering, but to withhold the request for Contract #3 until the quantity overrun issue has been reconciled, and to authorize H. E. Seufer to sign the corrected documents when they are prepared. R. J. Mullenix second. Unanimous.

Discussed RUS Budget. S. L. Nulter moved to approved the budget as published. R. J. Mullenix second. Unanimous.

S. L. Nulter moved to pay Resolutions 1 & 2 as published. R. J. Mullenix second. Unanimous.
