Reviewed progress of Water Loss Project. District monthly unaccounted for water loss is at 31%. It was discussed, and decided, that we should start working on the metering of each zone area, to help detect leaks more quickly.

The Board discussed the findings of the FY 18-19 Financial Statements, prepared by Bennett and Dobbins. G. K. Arnott moved to accept as presented. C. E. Lancaster second. Unanimous.

The Board reviewed, and agreed with Kelley Sanders' recommendation, that we do not renew our annual membership with the AWWA. We do not receive many benefits for our dues.

The Pleasant's County Commission submitted a request to extend water service to seven customers located on Homestead Drive and Steele Farm Road, as a PSC Water Rule 5.5 line extension agreement. The district share will be \$16,868.88. The Board directed Kelley Sanders to go ahead and collect an estimate for the work, to see if the Commission is interested in pursuing it any further.
