Minutes from board meeting held on June 7, 2022 were read. G. K. Arnott moved to accept the minutes. D. A. Raines second. Unanimous.

Reviewed monthly financial statements. G.K. Arnott moved to approve the financial statements, under protest. D. A. Raines second, with heavy sigh. Unanimous.

Fred Hypes, Dunn Engineering, provided an update for the sewer project. Currently they are working with the DEP to get their approval.

Mr. Hypes also presented an estimate, and engineering contract, for the work to be completed on the Middle Ridge Extension critical needs project. G. K. Arnott motioned to approve Dunn Engineers to move forward with the Mid-Ohio Valley Regional Council to submit the critical needs application in the amount of \$1,200,000, as well as the engineering contract in the amount of \$132,500. D. A. Raines second. Unanimous.

Bennett & Dobbins submitted a contract to allow for them to prepare the financial statements for FY 2021-2022. The cost will be \$5,600. G. K. Arnott moved to approve the contract. D. A. Raines second. Unanimous.

Customer concerns – none

Personnel issues – none

This month's District unaccounted for water loss is 5% (236 gallons per customer). We now have four AFC Semper devices located in the District to track pressure. These results were reviewed.

Water loss for the FY 21-22 was 7%.

A new sewer ordinance was reviewed by the Board members. After discussion, G. K. Arnott moved the approve the ordinance as written, D. A. Raines second. Unanimous.

James Kelsh, Bowles and Rice attorney, presented a new Legal Services Agreement for the Board to review, and approve. This contract is more representative of the work that will be required of Mr. Kelsh to help us complete the sewer project. The fee of \$44,000 remains the same. G. K. Arnott moved to approve the new contract. D. A. Raines second. Unanimous.
