Minutes from the regular board meeting held on November 8, 2022 and the special board meeting on November 15, 2022 were read. G. K. Arnott moved to accept the minutes. D. A. Raines second. Unanimous.

Reviewed monthly financial statements. G.K. Arnott moved to approve the financial statements. D. A. Raines second. Unanimous.

Clay Riley, Dunn-Thrasher Engineers, gave an update on the Sewer Renovations project. They are currently working with a Geotech on the Fordyce property in order to verify that the land is stable enough to place the line in the area that has been negotiated by all parties. Mr. Kanti Patel, Geotechnical Engineer, will visit the property on Wednesday, December 14, 2022, weather permitting.

Mr. Riley also gave an update on the Water Pressure Zone update. They are currently verifying some District information, including industrial users needs and pressures. That should help them wrap up the project.

There is no update on the Middle Ridge Critical Needs Project this month. The Infrastructure Council has continued to leave all Critical Needs Projects tabled for now.

Katrina Kratche, Mid-Ohio Valley Regional Council, presented Drawdown #2 for the Sewer Renovation project. G. K. Arnott made motion to approve the drawdown. D. A. Raines second. Unanimous.

Customer concerns – none

Personnel issues – Debbie Hoffman, Customer Service Representative, quit her job without notice. Shelby Walker has been hired to replace her.

Kelley Sanders presented the Amendment to the Plan Documents for the Cafeteria Plan from TASC. This amendment modifies the employee's ability to revoke an election of family coverage under the employer's group health insurance provided they are eligible to enroll in the Marketplace Coverage pursuant to guidance issued by the Department of Health and Human Services, and that the new coverage is effective beginning no later than the day immediately following the last day of the coverage that is being revoked. Greg moved to approve the amendment as presented. D. A. Raines second. Unanimous.
