EXISTING PACKAGE PLANT DEMOLITION & LINE REHABILITATION:

- A) Ron continues to work on maintenance of the Hyview Terrace Plant.
- B) The men have taken the Somer Villa plant out. We will be attacking the Lubeck School plant next since we have yet to hear from Cindy in reference to the southern part of the state needing a plant.

DISCUSSION OF DISTRICT HAPPENINGS:

It was reported what has been going on in the District:

- A) Installed 2 water tap since the last Board meeting. There is 1 water tap to be installed. This gives us 64 water taps for 2001. The District has installed 1 sewer taps since the last Board meeting. There are 0 sewer taps to be installed. This gives us 10 sewer taps for 2001.
- B) Inspected sewer connections, etc.
- C) Worked on cleaning up tap and repair locations.
- D) Worked in cooperation with the guys removing the Somer Villa sewer plant.
- E) Completed work orders, spotted lines, set meters.

GENERAL BUSINESS:
