# EXISTING SEWER PLANT AND DEMOLITION, ETC.:

- A) Charlie and Mark continues to work on operation and maintenance of the Hyview Terrace plant. The District has also installed the dechlorination unit as required by our new discharge permit.
- B) Hauled dirt to Pahlhurst Plaza to put in area where it sank in the plants.

## **DISCUSSION OF DISTRICT HAPPENINGS:**

It was reported what has been happening in the District:

- A) Installed 0 water taps since the last Board meeting. There is 1 water tap to be installed. This gives us 4 water taps for 2003 calendar year. The District has installed 0 sewer taps since the last Board meeting. There are 0 sewer taps to be installed. This gives us 1 sewer taps for 2003.
- B) Continuing to repair yards from leaks and taps.
- C) Did turn off and turn ons for the month.
- D) Removed two (2) water services from Corridor D project area.
- E) Removed two (2) sewer services at Tebays little houses.
- F) Installing more pro read meters.
- G) Dug up sewer main at Bethel where it had become full of tree roots, replaced a portion of the clay main with plastic pipe.
- H) Mike Smith is working in the water plant while BIII Gibbs has surgery to his shoulder. He will be out approximately six (6) weeks.
  - I) Completed work orders, spotted lines, set meters, etc.

### **GENERAL BUSINESS:**

- A) Moved by Lee Johnson, seconded by Jim Smith that all bills be approved as reviewed by management and the Board, in addition to all fund transfers as presented. Passed unanimously.
- B) The District will be hiring out the mowing this year as was done last year and for the same pricing.
- C) The District has received a telephone request for a water line extension to South Street off Gihon Road. Jim has told them that they need to bring us a written request for the extension. They say they have a contractor that will put the line in for \$1. per foot. We will wait and see.
- D) John Padden wanted Jim to let the Board know that he is putting all of our insurance out for bid. He is not pleased with what he is seeing as an increase.
- E) The District has learned through the Rural Water Association newsletter that Lubeck will no longer have to have our engineering agreements approved by the Public Service Commission since we are a Class A utility.
- F) The District has resubmitted our Infrastructure information to them for the funding of the Wadesville Water Project. We will have to wait and see how they review it this time.
