A) Moved by Jerry Martin, seconded by Paul Smith that the minutes of the Board meetings of September 15, 2005 and the Special Meeting of September 22, 2005 be approved. Passed unanimously.

DISCUSSION OF DISTRICT HAPPENINGS:

It was reported what has been going on in the District:

- A) Installed 5 water tap since the last Board meeting. There are 3 water taps to be installed. This gives us 43 water taps for 2005. The District has installed 2 sewer taps since the last Board meeting. There are 0 sewer taps to be installed. This gives us 11 sewer taps for 2005.
- B) Completed shut offs and turn ons.
- C) Training on the new line locator.
- D) Repaired one water line leak.
- E) Repaired yards from leak and tap installations.
- F) Ran the jetter and sewer camera in Bethel.
- G) Repaired hydrants.
- H) Cut trees from the entrance to the wastewater treatment plant.
 - I) Started clearing right of way on New England Ridge.
- J) Completed work orders, spotted lines, set meters.

GENERAL BUSINESS:

- A) Moved by Paul Smith, seconded by Jerry Martin that all bills be approved as reviewed by management and the Board, in addition to all fund transfers as presented. Passed unanimously.
- B) Moved by Jerry Martin, seconded by Paul Smith that the District accept the July 1, 2004 June 30, 2005 audit as performed by Altman and Associates, CPA's. Passed unanimously.
- C) The District has filed our Public Service Commission report for the period July 1, 2004 June 30, 2005.
- D) Moved by Jerry Martin, seconded by Paul Smith that the District sign the sewer easements through the District's existing property at Tarrytowne, Bethel #1, and Lubeck Hills. Passed unanimously.

- E) Moved by Jerry Martin, seconded by Paul Smith that the District approve the payment request for the water project in the amount of \$339,058.49. See attached Resolution. Passed unanimously.
- F) Moved by Jerry Martin, seconded by Paul Smith that the District sign Change Order #2 for Everett L. Harper & Son, Inc. Contract 03-1 in the amount of \$5,578.00 for additional valves and hydrants. Passed unanimously.
- G) Moved by Jerry Martin, seconded by Paul Smith that the District sign Change Order #2 for Contract 03-2 and Change Order #1 for Contract 03-3 for Mid Atlantic Storage Systems, Inc. for a reduction of a total of \$1,284.00. Passed unanimously.
- H) Mr. Flinn was here to let us know of his continued interest in getting water.
 - I) A question was asked about the two hearing before the Public Service Commission that are scheduled for October 6. Discussion was held on how these two cases might be handled. It was asked that the Board adjourn for a period of time for the Plaintiffs to discuss among themselves what might be done.
