BUSINESS: Prayer by Jerry Martin with Pledge following.

A) Moved by Roger Martin, seconded by John Sines that the minutes of the Board meeting of April 8, 2010 be approved. Passed unanimously.

DISCUSSION OF DISTRICT HAPPENINGS:

It was reported what has been happening in the District:

- A) Installed 3 water taps since the last Board meeting. There are 0 water taps to be installed. This gives us 4 water taps for 2010. The District has installed 1 sewer tap since the last Board meeting. There are 0 sewer taps to be installed. This gives us 2 sewer taps for 2010.
- B) Repaired 4 service line and 0 main line water leaks.
- C) Mowing of properties.
- D) Working on yard restorations.
- E) Completed flushing water lines.
- F) Installed 4 water sampling stations.
- G) Completed work orders, spotted lines, set meters.

GENERAL BUSINESS:

- A) Moved by Roger Martin, seconded by John Sines that all bills be approved as reviewed by management and the Board, in addition to all fund transfers as presented. Passed unanimously.
- B) Moved by John Sines, seconded by Roger Martin that the District authorize Jerry R. Martin, Chairman to sign the Authorizing Resolution and the Cost or Price Summary Format for Subagreements for the Engineering Agreement in reference to the Lake Washington Club Sewer Project. Passed unanimously.
- C) Wadesville Water Project The District continues to work on obtaining easements and users. Also, we have received almost all of our permits back for construction. We are still waiting on the Corp and Department of Highways. We continue to supplement our filing to the PSC with additional information to keep them from trying to kick our filing out.

- D) Ball School Road Water Project I spoke to Delegate Poling and he told me he had finally been able to track the application down to the Development office. He said they were working on it and would then send it on to the Governor. When I spoke to the Development office, they said hopefully we should see something in about a month if no other catastrophes occur.
- E) Corp of Engineers work at the well field continues. They have been working on contouring the ground and seeding and strawing. They are still waiting on the last barge of stone.
- F) Tank Painting We continue to wait on the RUS to agree and sign the parity agreement. Burgess & Niple was able to get each of the three low bidders to give us a one month time extension on the loan closing. I have spoken with RUS and requested that they expedite the request in their other offices. They are hoping that we might have it back by some time in the first full week of May. We will, at the next meeting, be signing the paper work for the loan closing that would probably happen on May 14.
- G) Moved by John Sines, seconded by Roger Martin that the Board accept the March 2010 financial statements as prepared by Philip R. Postlewait. Passed unanimously.
- H) Moved by John Sines, seconded by Roger Martin that the District release the Wesbanco Pledged Securities that was in place for the 2005 Water Project. Passed unanimously.
